As part of the above, to consider how it can ensure a joined-up approach to the issue given the different services that may come into contact with potential modern slavery, considering: the identification and referral of victims; support for victims through relevant services, eg safeguarding children and adults with care and support needs and through housing/homelessness services; community safety services and disruption activities.
