MOTION - STRATEGIC OBJECTIVE - SUSTAINABLE COMMUNITIES

Following the various public meetings held and initial consultations undertaken by ward councillors representing the Merton town centres most affected, this Council recognises and shares the very considerable concern and anxiety felt by many residents and existing businesses about the impact of the Crossrail 2 proposals which were recently subject to consultation, and the following aspects in particular:

- Reduced quality of life for local residents as a result of disruption, noise and increased traffic congestion throughout the lengthy redevelopment;
- Unacceptable levels of upheaval and disruption to the local business community for up to 10 years;
- Loss of certain landmark buildings which currently enhance the borough's heritage and character;
- Loss of residential properties and gardens along with considerable amounts of commercial floor space;
- Lack of detail about how compensation for blight will be considered;
- Risk to the local economy of creating a dormitory suburb dominated by one-way commuting to central London; and
- Lack of detailed work, including traffic modelling, on options for West Barnes and Motspur Park level crossings.

This Council also regrets the lack of information provided by Crossrail 2 to residents in Merton both about its current proposals and in publicising details of the recent formal consultation.

In addition to the formal cross-party response submitted to the most recent round of consultation, this Council therefore:

- 1) Calls on Crossrail 2 to:
 - a) Reject the decimation of Wimbledon and other affected town centres;
 - b) Consider in detail other viable solutions that would minimise the impact and disruption for the borough's residents and businesses; and
 - c) Hold further discussions with residents, business groups, councillors and other elected representatives in the areas affected at the earliest possible opportunity.
- Requests that Merton's Cabinet brings forward the timetable for its master planning process to establish a long term vision for Wimbledon so that work can commence as quickly as possible on developing a clear framework – in conjunction with residents and business groups - to guide the future development and regeneration of this major town centre.

Furthermore, this Council resolves to forward a copy of this motion to Michèle Dix, Managing Director of Crossrail 2.

Cross Party Motion

Merton Council supports the strategic case for Crossrail 2 and recognises the benefits it would provide to London and could bring to Merton. However, our support for Crossrail2 is not at any cost and the Council has strong reservations about the proposals, which have recently been subject to consultation.

In particular we are concerned about the impact of those proposals on our town centres and particularly Wimbledon, which is now in a uniquely vulnerable position. These proposals would bring about an unacceptable level of upheaval and disruption to our residents and our business community for an extended period of up to ten years: to a greater extent than we are aware has occurred in any other town centre in recent history.

Wimbledon is a very successful business centre with a low vacancy rate and a current unmet demand for modern office accommodation. We believe that it is vital that the vibrancy and quality of Wimbledon town centre is maintained before, during and after Crossrail2 works. We note that more than 3000 jobs are at stake.

Wimbledon SW19 is a globally recognised brand that has enormous potential for the future. This Council believes that Crossrail2 must fulfil that potential and not damage it. We understand that the consultation scheme is an early concept design. However, if the current proposals are not changed, we would be forced to reconsider our support for the project.

This Council believes that the options for delivering Crossrail2 through the Borough should be reassessed fundamentally with a view to minimising disruption and ensuring that businesses continue to prosper in a high quality town centre that retains the heritage and essential qualities of Wimbledon that we all cherish.

We are also concerned at the potential negative impacts on Raynes Park and Motspur Park. Changes to these stations will be required and there need to be viable alternatives to the level crossings. We note that "diversions" as quoted as one option put forward seems to mean "close the level crossing and expect all vehicles to find alternative routes" which would lead to increased traffic congestion in the Raynes Park / West Barnes area. Closure of the level crossing at Motspur Park could result in many of the local businesses leaving.

We invite Crossrail2 to join the Council, Love Wimbledon, landowners and our residents in a comprehensive master-planning process to create a framework for the future of Wimbledon based on the principles set out in this motion.
