



#### ANNEX 1 TABLE OF MANDATORY CONDITIONS UNDER THE LICENSING ACT 2003

- 1. That no supply of alcohol may be made under the premises licence
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- **2**. That every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- **3**. Where one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority by a licence granted under the Private Security Industry Act 2001 or entitled to carry out that activity by virtue of section 4 of the Private Security Industry Act 2001.
- **4.** (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
    - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

- **5.** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- **6.** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 7. The responsible person must ensure that -
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- **8.** A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 9. For the purposes of the condition set out in paragraph 1—
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula—

 $P = D + (D \times V)$ 

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or

- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- **10.** The admission of children to the exhibition of any film is to be restricted in accordance with any recommendation made by the relevant film classification body or relevant licensing authority.
- **11.** No condition may be attached to the licence as to the nature of the plays which may be performed, or the manner of performing plays, under a licence that permits the performance of plays.


Conditions attached after a hearing by the licensing authority

- 1. That the installed CCTV shall be maintained and operated the whole time that the premises are open to the public in accordance with the following:
- (a) Recordings shall be kept securely for a period of 1 month and be available for inspection by both the police and officers of the Council;
- (b) The CCTV system shall be serviced and maintained on an annual contract with a company specialising in the maintenance and repair of CCTV systems;
- (c) Recordings shall be made available at all reasonable times to the Police or duly authorised officers of the Council and there shall be a member of staff on duty at all times with the ability to operate the CCTV system;
- (d) The CCTV system shall cover and record images of entry and public areas;
- 2. Any outside space authorised for outside licensable activity shall not operate and shall be closed to customers from 22:30 each night;
- 3. Alcohol shall only be served with table meals;
- 4. An incident/log book shall be used and made available for inspection by police and duly authorised officers of the council;
- 5. The outside of the terrace shall be screened to a standard approved by the licensing authority to prevent interaction with the public, to act as a noise barrier and to act as a safety feature;
- 6. The premises shall operate a "Challenge 21" policy;
- 7. No music speakers are to be placed on the outside terrace;
- 8. There are to be no off-sales from the premises.



Premises Plan: Drawing '5787-1' of 24/08/2012.










ORIGINAL PREMISES LICENCE PLAN

### Full Variation Application: Chimichanga, 80 The Broadway, London SW19 1RH (the "Premises")

Our clients have taken on board the various concerns that have been raised regarding the recent variation application made in respect of the Premises.

Accordingly, our clients would like to vary their application to instead offer up the following condition to replace condition 3 of Annex 3:

"Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal."

Therefore, only those persons who are about to eat, or who have already eaten, will be allowed to drink in the holding bar. The ancillary bar will be designed to improve customer experience and will not be available to those who are not taking a meal at the premises.

The desire to add a holding bar to the restaurant is not designed to increase alcohol sales but is rather to assist with the flow of customers into the restaurant rather than allow members of the public to queue outside or be turned away from the restaurant.

By way of background to this application, the restaurant is to be rebranded in the new year as a MEXIco, which is Prezzo Limited's newest concept. The restaurant is to be run by the same people behind Chimichanga and Prezzo and will continue to be a family friendly restaurant. There is currently one other MEXIco which is based in Derby. Please note that we do not want the variation to have effect until the restaurant is re-opened following the rebrand in early 2017.

Our clients have operated from the Premises for approximately four years. Since opening, the restaurant has not, so far as we are aware, had any issues or caused trouble to the local community under the current Premises Licence.

Our clients are committed to working hard to promote and support Merton District Council's lincensing objectives. Our clients operate family friendly restaurants which should not contribute to the anti-social alcohol related problems in the area.

We enclose a statement made by our clients' executive chef, Paul Lewis, who is responsible for delivering the MEXIco concept in Wimbledon. The statement illustrates that the restaurant will be a high class operation and, by analogy with the existing MEXIco in Derby, alcohol sales makes up only approximately 15% of total sales.

Our clients feel that they have taken on board the concerns of the Police, the Public Health department, local councilors and the local people and hope that they can work together in order to incorporate a number of their suggestions in order to ensure that the four key licensing objectives continue to be met.

As such we enclose a list of additional proposed conditions to the Premises Licence along with the introduction of a new Condition 3 of Annex 3.

In order to further allay the concerns of any individuals we would like to invite all those who have raised representations to attend a meeting at Chimichanga in Wimbledon in order that we can discuss the contents of this letter and the restaurant concept further. This meeting is scheduled for <u>Tuesday 8 November 2016 at 6:30pm</u> and we will send out a separate invitation to those who have made representations.

#### **Replacement of Conditions:**

#### Condition 3 of Annex 3:

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

#### Condition 6 of Annex 3:

The premises will operate a "Challenge 25" policy whereby any person attempting to buy alcohol who appears to be under 25 will be asked for photographic ID to prove their age. The recommended forms of ID that will be accepted are passports, driving licences with a photograph, photographic military ID or proof of age cards bearing the 'PASS' mark hologram.

#### New Conditions to be added to Annex 3:

- 9. Suitable and sufficient signage advertising the "Challenge 25" policy will be displayed in prominent locations in the premises.

- 11. There shall be appropriate signage at the premises requesting customers to leave quietly.

#### **STATEMENT OF PAUL LEWIS**

#### **EXECUTIVE CHEF AT MEXICO DERBY**

- 1. I have been an employee of Prezzo Limited (formerly Prezzo Plc) since June 2004 as Executive Chef.
- 2. Prezzo Limited current operate five brands; Prezzo, Chimichanga, Cleaver, Caffe Uno and MEXIco.
- 3. We are always looking at ways in which we can improve the experience of our customers when they visit our restaurants. Our newest concept, MEXIco, is the result of a collaboration with a famous Mexican chef who has a string of restaurants across the United States of America.
- 4. The aim of our MEXIco restaurants are to bring customers the true taste of Mexico. Authenticity is at the heart of what we do, from the food, drinks, ingredients and artwork. We want to bring the colour of Mexico alive.
- 5. Our first MEXIco restaurant opened in Derby in July 2016. The Derby Premises Licence allows for unrestricted sale of alcohol but this is not something which we wanted or needed to take advantage of by having anything but a restaurant operation.
- 6. Whilst in Derby customers are able to have a drink at the premises without eating, this will not be the case in Wimbledon. Only customers who are waiting for their table, or those who have eaten a table meal, may have a drink. As such, we have varied our application and volunteered a condition to this effect.
- 7. By having a holding bar, we are able to maximise the number of diners. It is often the case that customers have not reserved a table. Rather than these people going to another public house or bar in the local area to have a drink whilst they wait for their table, the holding bar will allow customers to stay with us while they wait. This will be a benefit to both our restaurant and the general public as I believe that this will have a positive effect on the cumulative impact of all the other premises.
- 8. Our restaurant will continue to be food led. 70% of our sales in Derby currently comes from food. The remainder is made up of "wet sales", which includes soft drinks and tea and coffee. Alcohol sales only make up 15% of our total sales. MEXIco Derby continues to attract a wide range of age groups, including families, with the restaurant offering a children's menu alongside the main menu.
- 9. Since we opened our premises as a Chimichanga in Wimbledon we have sought to fully engage with the local community. Our restaurant is not a source of disorder and conflict. We specifically do not offer any drink promotions happy hour and "2 for 1" is just not part of what we do.
- 10. My team of highly trained and motivated staff are only too aware of their obligations to promote the licensing objectives under The Licensing Act 2003 and ensure that our restaurant does not have an adverse impact on the community of Wimbledon.

- 11. We welcome any feedback from local residents who have concerns or complaints regarding the manner in which our restaurant is run. I am happy to report that, to date, we have not had one complaint in our almost 4 years of operation from this premises.
- 12. I have organised a meeting with those residents, police and council departments who have made representations against our application. The purpose of this meeting is so that I can assure you that we are not turning the restaurant into a bar and that residents will notice little, if any, difference in the way the restaurant will be run. This meeting will be held on **Tuesday 8 November at 6:30pm** at Chimichanga in Wimbledon.
- 13. I look forward to meeting you all and putting faces to names. I am certain that we can continue to work together and make MEXIco a success for our business and the local community.

On 22<sup>nd</sup> Sept 2016 an application was received from Glovers Solicitors for a variation to a premises licence under the Licensing Act 2003.

The application can be summarised as follows:-

- 1. The current licensing plan is to be replaced with licensing plan 246-L03 annexed to the application.
- 2. Condition 3 of Annex 3 is to be varied to read:

"Alcohol should only be served with table meals except in the area hatched red on the plan 246-L03"

Police wish to make representations to this application on two of the four licensing objectives namely:-

### The Prevention of Crime and Disorder Public Nuisance

This premises is situated on a busy high street in close proximity to residential accommodation. The Broadway is the focal point for the borough's night time economy and as such already has nuneque various open late and selling alcohol.

The Local Policing Team (LPT) covering this ward have been consulted on this application and make the observation that there are issues in relation to street drinking in this area, alcohol related crime and anti social behaviour. There have been thirty-three (33) reported incidents of anti social behaviour in the last 12 months with thirteen (13) being alcohol related.

A search of crime indices has been carried out which revealed that in the year from 30<sup>th</sup> September 2015 to 30<sup>th</sup> September 2016 there were 48 crimes recorded within the postcode SW19 1RQ. Of these recorded crimes there were 24 Thefts, 2 Criminal Damage, 1 possession of drugs, 1 Robbery, 4 Public Order Offences, 15 assaults, and 1 Sexual Assault.

Chimichanga is situated within a Cumulative Impact Zone as Wimbledon Town Centre is already saturated with licensed premises. Chimichanga is next door to PoNaNa nightclub on one side and The Old Frizzle PH on the other. Chimichanga is opposite The Pod Bar nightclub, Wimbledon Theatre and Nandos Restaurant.

Chimichanga is situated in The Broadway at the junction with Kings Road and as such enjoys a highly visible dual aspect. The floor to ceiling windows along the whole of two sides of the building gives passers-by a very clear view of the large bright modern bar area along the length of the ground floor. Customers sitting at the bar will most certainly be seen by potential customers outside and, due to its clean, modern appearance and its prime location, Chimichanga could become an attractive venue for pre-nightclub drinks. I firmly believe that the feel and focus of the restaurant will completely change if the license variation is granted to allow alcohol to be served without a meal. This change will undoubtedly lead to an increase in crime and Anti-Social Behaviour in this already busy town centre.

The applicant has failed to describe any additional steps they intend to take to promote the four licensing objectives as a result of the proposed variation.

#### Conclusion

The premises can be said to be a responsible operator. However it is still felt that additional issues will arise if the licence variation is granted, specifically an increase in Crime and Anti-Social Behaviour in Wimbledon Town Centre.

#### I therefore strongly advise that the application be refused.

*If* the application to vary the Premises Licence is not refused, then please consider the addition of the following conditions:

- 1. Alcohol may be supplied and consumed by persons waiting for a table prior to their meal seated in the dining bar area, up to a maximum of six persons at any one time up to 9.30pm. (Replaces Annex 3.3)
- 2. The premises will operate a "Challenge 25" policy whereby any person attempting to buy alcohol who appears to be under 25 will be asked for photographic ID to prove their age. The recommended forms of ID that will be accepted are passports, driving licences with a photograph, photographic military ID or proof of age cards bearing the 'PASS' mark hologram. (Replaces Annex 3.6)

As a responsible authority under 2012 amendment to the Licensing Act 2003, the Director of Public Health for Merton wishes to make representation to the application on three of the four licensing objectives:

- 1. The prevention of crime and disorder
- 2. Public safety
- 3. Prevention of public nuisance

Tackling alcohol misuse is central to achieving the outcomes in Merton's Health and Wellbeing Strategy: giving every child a healthy start in life, supporting people to improve their health, improving wellbeing, resilience and connectedness, and reducing the gap in life expectancy between the east and west of the borough. We want to create an environment and a culture in the borough that prevents problem drinking from starting and provides early help for people who are struggling. One of the ways we will be doing this is ensuring health and wellbeing considerations are presented for consideration in licensing decisions, in order to tackle alcohol-related crime and anti-social behaviour, ensure public safety and prevent harm to children.

The Merton Joint Strategic Needs Assessment (JSNA) chapter on alcohol sets out a summary of the available evidence on alcohol-related behaviours and consequences, as background to the importance of tackling alcohol effectively in the borough: <a href="http://www.merton.gov.uk/health-social-care/publichealth/jsna/lifestyle-risk-factors/adults-substance-misuse/alcohol-jsna.htm">http://www.merton.gov.uk/health-social-care/publichealth/jsna/lifestyle-risk-factors/adults-substance-misuse/alcohol-jsna.htm</a>



Public Health are submitting a representation for three reasons:

- 1. The request for the supply of alcohol without food
- 2. The premises is located in one of Merton's Cumulative Impact Zone (CIZ) areas
- 3. Public health data for the premise postcode show some moderate areas for concern

Chimichanga is a chain of Tex-Mex restaurant situated in within the Wimbledon Broadway Cumulative Impact Zone (CIZ). Prezzo Limited currently holds a license (LN/000002435) that permits the supply of alcohol at Chimichanga, 80 The Broadway, Wimbledon, SW19 1RH from 10:00 until 00:00. This application requests to have a red hatched area on the plan 246-L03; where alcohol may be served with out food.

The applicant has taken no steps to identify how this change would affect promotion of the licensing objectives or recognise how to mitigate them. Furthermore, there is no reference to their location within the CIZ or sufficient measures suggested to mitigate the recognised problems within the vicinity.

#### **Controlled Impact Zone** (see Appendix 2 for relevant parts of the SOLP)

The Merton Statement of Licensing Policy (SOLP) 2011 sets out that the cumulative impact of the number, type and density of licensed premises in a given area may lead to serious problems of nuisance and disorder outside and within the vicinity of these premises. Wimbledon Town Centre where the proposed premises is located is designated a Cumulative Impact Zone. In a CIZ, the Council may consider that the attachment of conditions is unlikely to address identified problems and it may then consider refusing new licences because the area is saturated and the granting of any more would undermine the licensing objectives.

There has been a significant increase in the number and scale of licensed premises in Wimbledon Town Centre over recent years. This has resulted in a significant number of alcohol related crimes and of complaints being made to the Council concerning nuisance. The Police have provided evidence regarding alcohol related crime and disorder and the connection between the offences and licensed premises. Anti-social behaviour has led to the Metropolitan Police designating part of the town centre as a dispersal area under the Anti -Social Behaviour Act 2003. Residents and Residents Associations in Wimbledon Town Centre have made representations that the Town Centre is at saturation point.

#### **Evidence of detrimental impact on the licensing objectives:**

The data presented relate to the postcode of the premises, and the ward within which the restaurant is situated. Although the data is not specific only to the premises in question, any premise that supplies alcohol in the area will be contributing to the trends relating alcohol to crime and disorder.

#### 1. The prevention of crime and disorder

Local data from the London Ambulance Service shows that in the year to October 2015, the following incidents occurred within 500 meters of the postcode for this premises:

- 14 alcohol-related incidents, 4 of which occurred within 200 meters of the postcode for this premises
- 6 Ambulance-reported assaults
- 3 Gun, knife and weapon injuries
- 2 least serious injuries, which are often used as a proxy for alcohol related harm
- 2 episodes of anti-social behavior reported by bus-drivers (both within 100 meters of the postcode for this premises)

Furthermore, the premise is situated in Trinity Ward, which ranks 1st out of all 20 Merton wards for alcohol illness treated by the London Ambulance Service in 26-39 year olds.

The above data (and that in Appendix 1) suggest an existing moderate impact of alcohol consumption in the local area but it is likely that the granting of this license as requested, particularly the late night hours where alcohol will be sold without meals, will only contribute to exacerbating the above trends relating alcohol to crime and disorder.

Public Health are also aware of police crime data linked to the postcode SW19 1RH that indicate the high frequency whereby the victim, suspect or both are known to have been drinking.

National and international scientific evidence shows the following:

- Overall, more alcohol is consumed when it is easily available.<sup>1</sup>
- An increase in alcohol sales is strongly linked to an increase in drinking-related damage, for instance injuries and assaults.<sup>2</sup>
- Harmful use of alcohol is a major contributor to violence: alcohol use commonly precedes aggressive behaviour, and harmful drinking is associated with being both a perpetrator and a victim of violence<sup>3</sup>
- Reducing the availability of alcohol through regulating sales outlets, hours and prices can substantially decrease violence.<sup>4</sup>

#### 2. Public Safety and

#### 3. Prevention of public nuisance

Chimichanga, 80 The Broadway, Wimbledon, SW19 1RH is located in the CIZ, an area where it is recognised that there is already a problem with the impact of alcohol on public safety and public nuisance. The data on assaults and violence (above and in Appendix 1) paints a picture of the impact of alcohol consumption in this specific area on both public safety and nuisance. In addition, the most recent Annual Residents Survey highlighted that nearly half of all residents in this area of the borough are very worried or fairly worried about people being drunk and rowdy, which is the area with the most worried residents in Merton (Appendix 3).

Furthermore, this restaurant is situated in close proximity to residential housing. Any increase in pedestrian traffic will have an impact in the local area in terms of noise and nuisance. Public Health have also been made aware of concerns raised by local residents about the on-going issues with antisocial behaviour and the impact it is having on their quality of life in the area surrounding the restaurant.

#### Conclusion

The applicant has not stated the steps they will take to promote the licensing objectives, and we believe this is insufficient to prevent an additional impact of supplying alcohol without meals on the levels of alcohol-related crime and disorder and issues around public safety already seen in the area. There are likely to be detrimental consequences to the licensing objectives, and to broader health and wellbeing, of this license being granted. The Merton SOLP states that it is "for the applicants to show in their operating schedules that their proposals will not add to the cumulative impact already being experienced." (Appendix 2)

#### Recommendation: Public Health would recommend that the Committee reject the application.

However, if the committee is minded to approve the application, and based on the information provided, we would recommend that the following conditions are maintained or applied to the licence to further promote the prevention of crime and disorder, to promote public safety and prevent public nuisance.

- 1. No super-strength beer, lagers or ciders, or spirit mixtures of 6.5% ABV (alcohol by volume) or above shall be sold at the premises.
- 2. Alcohol shall be sold to customers by waiter/waitress service only.
- 3. Alcohol shall only be sold to a person sitting down eating a meal and for consumption with that meal.
- 4. No drinks to be taken off the premises in open containers e.g. glasses or open bottles (preventing use of containers as weapons, and to prevent consumption of alcohol in surrounding streets after individuals have left the premises).
- 5. Drinkaware will be promoted through the business website and drinking sensibly and appropriately will feature on any menus and marketing literature.
- 6. Any promotional material online or elsewhere will adhere to the Portman Group Code of Practice (httpp://www.portmangroup.org.uk/codes/alcohol-marketing/code-of-practice/code-of-practice).
- 7. Refusals of alcohol sales shall be recorded in a log and made available for inspection by an authorised officer of the council or police when requested.
- 8. A proof of age policy such as Challenge 25 shall be operated at the premises whereby any individual suspected to be under age will be required to provide a recognised form of photographic identification.

We believe that these conditions are reasonable and proportionate in order to promote and maintain the Merton CIZ's, and a safe and sociable approach to alcohol across the borough.



### Excerpts from the Merton Statement of Licensing Policy 2011 relevant to the Cumulative Impact Policy (paragraphs 7.8-7.10 of the Policy):

- 7.8 The Council considers that it is appropriate and necessary to continue a special policy within the designated cumulative impact zones. Where relevant representations have been received the policy will affect applications for new premises' licences or club premises' certificates or variations of existing licences or certificates. It will be for the applicants to show in their operating schedules that their proposals will not add to the cumulative impact already being experienced. Responsible authorities and/or interested parties will need to see the steps proposed by an applicant in order to decide whether to submit representations. The presumption will be that where proposed operations are material to the policy they will normally be refused, however, the process allows applicants to rebut the presumption in their applications, and to make the case before a licensing sub-committee. Where an application is material to the special policy the burden of proof lies on the applicant to rebut the presumption.
- 7.9. The presumption of a refusal does not, however, relieve responsible authorities or interested parties of the need to make a relevant representation, as the special policy can only lawfully be invoked by a licensing sub-committee, which has been convened in response to valid representations that refer to that special policy. If no representation were received it would remain the case that any application must be granted in terms that are consistent with the operating schedule submitted. Responsible authorities, such as the Police, or interested parties, can make a written representation maintaining that it is necessary to refuse the application in order to meet the licensing objectives. In doing so they should refer to the special policy and any information, which had been before the licensing authority when it developed its Statement of
  - Responsible authorities, where they have promoted or provided the evidence to support a special policy, should consider carefully any implications that maybe drawn from their not making a representation.

Licensing policy.

7.10 This special policy is not absolute. The circumstances of each application will be considered properly and it is possible for licences and certificates that are unlikely to add to the cumulative impact on the licensing objectives to be granted. As a consequence of the presumption that underpins the special policy such cases are likely to be exceptional. Following receipt of representations in respect of a new application for or a variation of a licence or certificate, the Licensing Authority will consider whether it would be justified in departing from its special policy in the light of the individual circumstances of the case. Notwithstanding the significance of the special policy the Licensing sub committee will announce its reasons for any decision to refuse an application.

#### APPENDIX 3: Public Health data on alcohol in Merton & Trinity Ward (premises location):

Nationally, alcohol is the leading risk factor for preventable death in 15-49 year olds. Nine million adults now drink at levels that increase the risk of harm, of which 1.6 million show signs of alcohol dependence. The number of people dying due to liver disease in England is rising, in contrast to other major causes of disease that have been declining.<sup>5</sup> The harm of alcohol falls not just on individuals and their health, but on society as a whole. Alcohol misuse is associated with a wide range of criminal offences, including drink driving, being drunk and disorderly, criminal damage, assault and domestic violence, all of which can also indirectly impact on health. In younger people, risky drinking behaviour is associated with anti-social behaviour and teenage conceptions.

The estimated prevalence of binge drinking is 13.8% compared with 14.3% in London and 20.0% nationally. However, this masks differences across the borough. Estimated levels of the adult population drinking at 'increasing risk' (21%) and 'higher risk' (7.2%) are above London average, and again, drinking patterns vary across the borough.

In terms of alcohol harm overall, in 2012 Merton ranked 55 out of 326 local authorities (Local Alcohol Profiles for England, LAPE 2012) but was in the higher percentiles for:


- Male mortality chronic liver disease (104/326)
- Female alcohol-specific hospital admissions (106/326)
- Male alcohol-specific hospital admissions (109/326)
- Male alcohol-attributable hospital admissions (151/326)
- Alcohol-related violent crimes (192/326)
- Alcohol-related sexual offences (208/326).

The amount of harm caused by alcohol also varies across the borough.

# Expected Prevalence of Alcohol Consumption at Home in Merton by Ward: Once a Day or More.



In terms of all alcohol-related crime, Merton with a rate of 7.3 recorded crimes per 1,000 populations was higher than the neighbouring boroughs Sutton (6.7) and Kingston (6.7) and the England average of 7 but lower than the London average of 11.1 (LAPE 2012). See Figure 2. Figure 3 shows that the trend has generally been downward.

Figure 3: Recorded crime attributable to alcohol, Merton compared with South West London, London overall, England, 2011-12.






Figure 4: Alcohol-related crimes in Merton, 2008-09 to 2012-13.

Do you consider this lack of detail sufficient?


As previously stated in relation to such alcohol requests, the Broadway already suffers from significant anti social behaviour, public health and safety issues as a result of such license variations being granted. A robust approach must be taken by the committee to avoid further alcohol fuelled offences and concerns that arise. Serving alcohol without food only fuels the problem we have with late night drink on the Broadway and all the public health and safety concerns that affect Trinity Ward residents. Poo Na Nas is a difficult spot for those who live on South Park and King's road residents, the restaurant next door having such a variation granted will only fuel a problem that is already spiralling out of control at the detriment of residents who live close to the Broadway. They have to live and sleep through the effects of such licences every weekend.

Trinity Councillors have a zero tolerance policy to such licence variations.

It is requested that condition 4 be removed to allow the sale of single cans/bottles of beer, lager or cider.


4. No single cans/bottles of beer, lager or cider will be sold at the premises. Such cans or bottles to be sold only sealed packs of four or more.

Due to the size of the premises there is a limited amount of stock available for sale. The beers/lagers and ciders are of a premium nature and as such are more expensive than other outlets in the near vicinity. #### Annex 1 - Mandatory conditions

#### Mandatory conditions where licence authorises supply of alcohol

Where this premises licence authorises the supply of alcohol, the following conditions shall apply:

- no supply of alcohol may be made under the premises licence:
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
  - (c) every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

#### Mandatory condition: exhibition of films

Where this premises licence authorises the exhibition of films, the admission of children to the exhibition of any film shall be restricted as follows:

- (1) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children shall be restricted in accordance with any recommendation made by that body.
- (2) Where:
  - (a) the film classification body is not specified in the licence, or
  - (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question, the admission of children shall be restricted in accordance with any recommendation made by that licensing authority.
- (3) In this section:
  - (a) "children" means persons aged under 18; and
  - (b) "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

#### Mandatory condition: door supervision

- (1) Where this premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, all door supervisors shall be licensed by the Security Industry Authority (SIA).
- (2) But nothing in subsection (1) requires such a condition to be imposed:
  - in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
  - in respect of premises in relation to:
  - any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
  - any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section:
- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

#### **Prohibited conditions: Plays**

If this premises licence authorises the performance of plays, no condition shall be attached to the licence as to the nature of the plays that may be performed, or the manner of performing plays, under the licence.

- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4.—(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

# Annex 3 Conditions attached after a hearing by the licensing authority

- 1. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorised officer throughout the preceding 31 day period. The CCTV system should be updated and maintained according to Police recommendations.
- 2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised council officer recent data or footage with the absolute minimum of delay when requested.
- 3. No spirits, super strength beer, lager or cider of 5.5% ABV or above shall be sold at the premises.
- 4. No single cans/bottles of beer, lager or cider will be sold at the premises. Such cans or bottles to be sold only sealed packs of four or more.
- 5. A proof of age scheme, such Challenge 25 shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport, or holographically marked PASS scheme identification cards.
- 6. A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by the Police or an authorised council officer at all times whilst the premises are open.
- 7. An incident log shall be kept at the premises and made available on request to the Police or an authorised council officer, which will record the following: All crimes reported to the venue



Thanks Stephen for your advice.

I have been asked by the local residents to join and support their objections to the granting of this premises licence. I would like to make representation on the grounds of prevention of crime & disorder and the prevention of public nuisance as follows:

The Savana - Unit 2 premises are located within a few yards of a Cumulative Impact Zone. The off license being applied for means that it is likely that the alcohol purchased in portable and disposable containers will contribute to existing problems relating to this cumulative impact zone.

I am surprised that the Met Police or London Transport Police have not objected to this application. There is the likelihood of customers taking alcohol on to buses, trains and trams in contravention of existing regulations prohibiting the consumption of any alcohol on public transport. Presence of transport Police is minimal at Wimbledon Station and it would be difficult to enforce or monitor.

Residents in adjacent areas in Trinity Ward have all suffered from late night revellers using their streets and gardens as toilets on their way home. Additionally the alcohol bottles/containers used by the noisy revellers are not recycled but strewn around this Conservation Area.

There are already sufficient outlets selling alcohol until 2200 hours (Morrisons) and by granting this license this would contribute to the existing problems being experienced in this area.

When Morrisons applied to extend their licensing hours, a paper was prepared by Merton Council looking at the impact of further licensing applications in the town centre.

This paper was not presented as Morrisons withdrew their application at the eleventh hour. I will grateful if you can provide me with a copy of this paper and suggest that it is also presented to the licensing committee on this occasion.
