1. Special Policy Area (premises licences and club certificates)

1.1 The premises are not in the special policy area.

2. Type of hearing and powers of the sub-committee

- 2.1 The sub-committee is required to determine the application by taking such of the steps set out below as it considers necessary for the promotion of the licensing objectives.
- 2.2 In making their determination the sub-committee must have regard to the Licensing Act 2003, the licensing objectives, guidance issued by the Secretary of State and Merton's Licensing Policy.
- 2.3 Variation of premises licence: s35
 - (i) To modify the conditions on the licence
 - (ii) To reject the whole or part of the application.

3. Hearing papers

3.1 The applications, notices and representations for determination by the subcommittee are contained in the hearing bundles together with any relevant existing licence. This includes any documents which must be sent to any of the parties to the hearing under Regulation 7(2) and Schedule 3 of The Licensing Act 2003 (Hearings) Regulations 2005. This bundle has been issued to all parties to the hearing.

4. Legal advice to the sub-committee

4.1 A legal officer appointed by the Assistant Director of Corporate Governance and Head of Legal Services will attend the hearing to advise the subcommittee on statutory provision and legal matters.

5. Licensing Officer Comments

- 5.1 This is an application to vary an existing licence. The existing licence and associated plan forms part of this report.
- 5.2 The applicant wishes to extend the times when it can sell alcohol for consumption off the premises only and amend condition 3 in Annex 3 of their current premises licence.
- 5.3 The current licence allows the sale of alcohol for consumption off the premises, Monday to Sunday, between 07:00 to 23:00. They wish to extend this to Monday to Sunday until 02:00 the following morning.

- 5.4 The applicant states that there has been some negotiation with the Police regarding the condition and the applicant has amended their operating schedule. Instead of amending the condition to "No super-strength beer, lagers or ciders of 6.5% ABV (alcohol by volume) or above shall be sold at the premises", It would be "No super-strength beer, lagers or ciders of 5.5% ABV (alcohol by volume) or above shall be sold at the premises, **except for premium and craft beers**."
- 5.5 There is a condition in the operating schedule that states has been agreed with the Police, that the Sub-committee may wish to consider.
- 5.6 We have received 6 representations regarding this matter 1 Councillor, 2 Responsible Authorities, 1 residents association and 2 members of the public.

 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a) a holographic mark, or

(b) an ultraviolet feature.

5. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

6. For the purposes of the condition set out in paragraph 1—

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula-

 $P = D + (D \times V)$

where---

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 3 Conditions attached after a hearing by the licensing authority

1. The premises shall install and maintain a comprehensive CCTV system as per the minimum requirements of a Metropolitan Police Crime Prevention Officer. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 31 days with date and time stamping. Recordings shall be made available immediately upon the request of Police or authorized officer throughout the preceding 31 day period. The CCTV system should be updated and maintained according to police recommendations.

2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premise is open to the public. This staff member must be able to show a Police or authorized council officer recent data or footage with the absolute minimum of delay when requested.

3. No super-strength beer, lagers or ciders of 5.5% ABV (alcohol by volume) or above shall be sold at the premises.

4. A proof of age scheme, such as Challenge (21/25), shall be operated at the premises, where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence or passport / holographically marked PASS scheme identification cards.

5. A log shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection at the premises by the police or an authorised officer of the Council at all times whilst the premises is open.

6. An incident log shall be kept at the premises, and made available on request to an authorised officer of the Council or the Police, which will record the following: (a) all crimes reported to the venue

- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder

- (e) any faults in the CCTV system or searching equipment or scanning equipment
- (f) any refusal of the sale of alcohol
- (g) any visit by a relevant authority or emergency service.
- 7. Age related notices shall be displayed regarding sales of alcohol.

8. Notices shall be prominently displayed at all exits requesting patrons to respect the needs of local residents and leave the area quietly.



With regard to the current Licensing Application for Wimbledon Food & Wine, 226 Merton High St, Colliers Wood, on behalf of the Metropolitan Police, I would like to make the following objections on grounds of Public Nuisance..

The applicant wishes to extend permitted alcohol hours from 2300hrs to 0200hrs every night of the week. They also wish to raise the max abv of beer and cider currently permitted from 5.5% to 6.5%.

The premises is situated adjacent to and opposite residential areas, it is also close to South Wimbledon Underground Station which is now part of the Night Tube network. I am concerned that the extension of hours will encourage people to buy alcohol and loiter close to residential areas late at night. People returning home from enjoying Wimbledon town centre's Night Time Economy, or returning from central London will pass by Wimbledon Food & Wine on their way home. Stopping to buy alcohol will likely give rise to Anti Social Behaviour and public nuisance. This is a concern apparently shared by local residents commenting on a news article about the application published by Wimbledon Guardian. There are historic problems associated with the premises when under previous ownership.

I am also concerned about the applicant's desire to raise the 5.5% abv limit currently imposed to tackle ASB committed by street drinkers.

I ask the committee to consider revising the terms of the application if minded to grant the license. My recommendation is that the alcohol hours are extended to 0000hrs Monday to Thursday, and to 0200hrs on Friday and Saturday nights, 2300hrs on Sundays.

The condition that restricts max abv be amended to include "except for Premium and Craft beers".

To provide the confidence and ability to safely refuse sales of alcohol when necessary, I would like to see the following condition added to the licence if granted: "On Friday and Saturday evenings, there must be a minimum of two members of staff on duty at the premises from 2300hrs whilst open to the public"

From my discussions with the applicant's agent during the consultation, we almost reached agreement with the above. The applicant was reluctant to amend alcohol hours on Wednesdays and Thursdays.

As a responsible authority under the 2012 amendment to the Licensing Act 2003, the Director of Public Health for Merton wishes to submit a representation for this premises license variation, on the following licensing objectives:

1. The prevention of crime and disorder

2. Public safety

The premises in concern is currently licensed to sell alcohol (off the premises) from 07:00 to 23:00, Monday to Sunday. The applicant is seeking to extend these hours to sell alcohol from 07:00 to 02:00, seven days a week. Public Health is concerned about the extension of license hours for the following reasons:

- Public health data shows some areas for concern within the premises postal code
- Evidence of concern from local residents with regard to existing issues related to alcohol in the area
- Location of the premises is in close proximity to a tube station (South Wimbledon) which is served by the night tube on weekends, where customers who may already be under the influence of alcohol will have the availability of late-night opening off-licenses nearby.

Introduction and Background

Tackling alcohol misuse is central to achieving the outcomes in Merton's Health and Wellbeing Strategy.

A crucial element of tackling alcohol-related harm is ensuring that health and wellbeing considerations are met by premises licensed to sell alcohol within the borough, in order to prevent alcohol-related crime and anti-social behaviour, ensure public safety, and prevent harm to children.

Alcohol misuse is currently one of the biggest Public Health issues in the U.K., and it imposes a huge burden on our society.



Irresponsible drinking costs the taxpayer a staggering £21 billion a year.¹



Alcohol is currently the **biggest risk factor** for death, ill-health, and disability among 15-49 year olds in the UK.²



The cost of alcohol-related conditions to the NHS is £3.5 billion annually.³



Alcohol is a contributing factor in **75% of stabbings**, and **60-70% of murders**.⁴

Evidence of detrimental impact on the licensing objectives

1. The prevention of crime and disorder

The link between alcohol and violence has been recognized as far back as the 4th century BC. Alcohol-related violence causes substantial injury and death.⁵

Local data suggests there is a serious issue with crime and violence in the area surrounding the premises postcode.

Within 200m of the premises postcode, SW19 1AU,

- A. Alcohol-related issues in under 26 year olds falls in the top 1% of the borough
- B. BTP-reported violence falls in the **top 5%** for the borough
- C. Alcohol related issues (all ages) fall in the top 20% for the borough
- D. BTP-reported anti-social behaviour falls in the top 20% for the borough
- E. BTP-reported criminal damage falls in the top 20% for the borough

The above data suggests there is a significant impact of alcohol consumption in the local area. While the above data does not relate to the specific premise, any premises that supplies alcohol in the area will be contributing to the trends relating alcohol to crime and disorder. This is especially pertinent in this case where there is evidence of irresponsible trade and breeching of licensing objectives.

Moreover, the premises is located in close proximity to a tube station which is served by the night tube on weekends (South Wimbledon, Northern Line). The premises is therefore likely to be on the route home for commuters who may already be under the influence of alcohol, encouraging them to stay out longer and drink more.

2. Public safety

The recent Annual Residents Survey for Merton (2017) highlights that 17% of residents in this area of the borough are very worried or fairly worried about people being drunk and rowdy in public places. 23% are very concerned or fairly concerned about groups hanging around in the streets, and 15% of residents are very concerned or fairly concerned about people using or dealing drugs.⁶

- In terms of alcohol harm overall, in 2012, Merton ranked 55 out of 326 local authorities. This is
 to say that over 83% of boroughs in England have less alcohol harm overall than Merton. Within
 the borough, there is an element of variance in the degree of alcohol harm between different
 wards. Figge's Marsh, where this premises is located, has a higher admission ratio of hospital
 stays for alcohol-related harm than the figure for Merton and that for London.
- The crime rate in Abbey Ward is 6.6 offences per 1000 population. This is higher than the Merton value (5.4 per 1000 population), and the highest number of offences recorded is 'antisocial behaviour'.⁷

Conclusion


There is evidence revealing serious concerns about alcohol harm in the local population, and the location of the premises in concern is that which serves potentially vulnerable individuals. Therefore, we request that the application of variation to the Premise License WK/201800801 be rejected, and the premises licensed hours remain unchanged.

I strongly object to this licensing application.

It would encourage anti-social behaviour after drinking hours (pubs and restaurants nearby closing at 11pm), outside the drinking premises causing more nuisances to the residents of South Wimbledon community.

Directly opposite Wimbledon Food n Wine store, there's a likelihood large space-area for drinking behind the Kilkenny Tavern pub, also in front of properties on Hayward Close. Problems have been reported in the past and also would also encourage more empty cans and bottles littered into this area, as well as noise, urinating and increasing the probability of graffiti on the massively exposed wall behind the Kilkenny pub. This is obviously very unpleasant for the residents living nearby, hence no consideration for them.

Absolutely no respect would be given when it comes to other people's properties in back streets. Littered with beer cans and bottles. They find a quiet spot for 'urinating' purposes, as well as a drinking area space. The whole of the South Wimbledon area is <u>not</u> a "controlled drinking zone" after 11pm. I never once saw a Community Police Officer in the area at night times. Why should our residents be expected to clear littered beer cans and bottles thrown in their front gardens?

On behalf of the Battles Area Residents Association I have been instructed to make a representation in respect of the above licence variation application.

We are opposed to this variation on the basis of:

The Prevention of Crime and Disorder; The Prevention of Public Nuisance

The availability to purchase alcohol to AM, including stronger beers and ciders, would attract people to the High Street to hang around, cause a nuisance, with noise, leave litter, which is already a problem, and urinate in the nearby streets, which as a group we are actively trying to resolve with the Council, to improve the area which we believe this licence would definitely not benefit us as a community.

As the Tube is now running through the night at weekends, if local residents were to come home late they may feel intimidated if drinkers were there. Although this is a High Street with flats above, some with families, shops have also been converted into flats and they deserve to have peace and relative quiet in the area.

If this licence were to be allowed it would increase the anti-social behaviour that as we all know is associated with alcohol in excess, this has been seen in Wimbledon Town Centre and with less police a totally unnecessary requirement to our area.

I hope these points are taken on board and you see fit to decline these longer hours of alcohol sales.

To allow the extension of the licence from 11AM to 2AM would set a precedent which would likely lead over time to a number of outlets supplying alcohol to persons who may wish to consumer them immediately in the street or in neighbouring streets such as Hamilton Road Mews which is immediately behind the premises.

To Licensing, London Borough of Merton.

We were recently informed Wimbledon Food n Wine on 226 Merton High Street have applied to extend their opening hours.

I would like to object on the grounds extended hours would increase the level of nuisances we already receive from customers of the store. They are;

- Next to the store there is a large metal blue box (similar to cable company street boxes though I'm not sure what this one is used for). Customers use the box as a makeshift table and female visitors to the house have felt intimidated when waking past customers who loiter around the blue box drinking. With the pubs nearby closing at 11pm I fear the area around the blue box will become an improvised pub by the loiters.
- There is an issue with litter. At mornings I frequently have to dispose bottles and cans left on the street. We can identify the litter was brought from the store and not the local Tesco and Sainsburys by the price tag or by the plastic bag they've been left in.
- Customers of the store who loiter around Hardy Road have urinated against the wall on our driveway. Again, we can tell they are customers of the store by easily identifying where the bottles and cans they leave behind, after they've urinated, were brought from.

I don't see how extending the opening hours of an off-license in a residential and family area can bring us any benefit. Should we need any emergency supplies late at night we are well serviced by the local Tesco and Sainsburys.

I am happy to discuss my objection in more detail.

Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.
- (2) The first condition is that no supply of alcohol may be made under the premises licence:
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition: exhibition of films

- (1) Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- (2) Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- (3) Where:
 - (a) the film classification body is not specified in the licence, or
 - (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

- (4) In this section:
 - "children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).

Mandatory condition: door supervision

- (1) Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, the licence must include a condition that each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires such a condition to be imposed-
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to:
 - i. any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - ii. any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section:
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Prohibited conditions: plays

- (1) In relation to a premises licence which authorises the performance of plays, no condition may be attached to the licence as to the nature of the plays which may be performed, or the manner of performing plays, under the licence.
- (2) But subsection (1) does not prevent a licensing authority imposing, in accordance with section 18(2)(a) or (3)(b), 35(3)(b) or 52(3), any condition which it considers necessary on the grounds of public safety.



As a responsible authority under the 2012 amendment to the Licensing Act 2003, the Director of Public Health for Merton wishes to support the review submitted by the Metropolitan Police for this premises license, on all four licensing objectives:

- 1. The prevention of crime and disorder
- 2. Public safety
- 3. Prevention of public nuisance
- 4. The protection of children from harm

Public Health is requesting this license review for the following reasons:

- Evidence of breeching of licensing objectives
- Evidence of selling alcohol to children, and unsupervised selling of alcohol by a child
- Evidence of two undocumented workers at the premises
- Public health data shows some areas for concern within the premises postal code.

Introduction and Background

Tackling alcohol misuse is central to achieving the outcomes in Merton's Health and Wellbeing Strategy.

A crucial element of tackling alcohol-related harm is ensuring that health and wellbeing considerations are met by premises licensed to sell alcohol within the borough, in order to prevent alcohol-related crime and anti-social behaviour, ensure public safety, and prevent harm to children.

Alcohol misuse is currently one of the biggest Public Health issues in the U.K., and it imposes a huge burden on our society.

Irresponsible drinking costs the taxpayer a staggering £21 billion a year.¹



Alcohol is currently the **biggest risk factor** for death, ill-health, and disability among 15-49 year olds in the UK.²



The cost of alcohol-related conditions to the NHS is £3.5 billion annually.³



Alcohol is a contributing factor in 75% of stabbings, and 60-70% of murders.⁴

Evidence of detrimental impact on the licensing objectives

1. The prevention of crime and disorder

The link between alcohol and violence has been recognized as far back as the 4th century BC. Alcohol-related violence causes substantial injury and death.⁵

Local data suggests there is a current serious issue with crime and violence in the area surrounding the premises postcode.

a) Bus-driver reported violence

Within 100m of the premises postcode, the number of incidents which have occurred falls in the **highest 5%** of areas in the borough.

- b) Bus-driver reported anti-social behavior
 Within 300m of the premise, the number of incidents which have occurred falls in the highest 5% of areas in the borough.
- c) Alcohol related issues

Within 300m of the premises post code, the number falls in the **top 20%** for the borough.

d) Figures for **gun, knife and weapon injuries** within 200m of the premises postcode fall in the **top 30%** for the borough.⁶

The above data suggests there is a significant impact of alcohol consumption in the local area. While the above data does not relate to the specific premise, any premises that supplies alcohol in the area will be contributing to the trends relating alcohol to crime and disorder. This is especially pertinent in this case where there is evidence of irresponsible trade and breeching of licensing objectives.

Moreover, the premises is situated in Figge's Marsh, one of the most deprived areas in the country⁷, home to a sizeable population of vulnerable people.

Figge's Marsh is ranked as the **No. 1 ward** in Merton for gun, knife and weapon injuries, and for violence. The Metropolitan police responded to a stabbing incident immediately outside the Ronnie's Cutter, where the perpetrator was seen to enter the premises afterwards, and this occurred outside of licensed opening hours. In such a high-risk area, there is absolutely no tolerance for irresponsible trading such as this.

2. Public safety

- The recent Annual Residents Survey for Merton (2017) highlights that 17% of residents in this area of the borough are very worried or fairly worried about people being drunk and rowdy in public places. 23% are very concerned or fairly concerned about groups hanging around in the streets, and 15% of residents are very concerned or fairly concerned about people using or dealing drugs. ⁸
- In terms of alcohol harm overall, in 2012, Merton ranked 55 out of 326 local authorities. This is
 to say that over 83% of boroughs in England have less alcohol harm overall than Merton. Within
 the borough, there is an element of variance in the degree of alcohol harm between different
 wards. Figge's Marsh, where this premises is located, has a higher admission ratio of hospital
 stays for alcohol-related harm than the figure for Merton and that for London.
- The crime rate in Figge's Marsh is 9.3 offences per 1000 population. This is higher than the Merton value (5.4 per 1000 population), and the highest number of offences recorded is 'antisocial behaviour'. ⁹

3. Prevention of public nuisance

• The premises in concern are located in the Cumulative Impact Zone (CIZ) of Mitcham Town Centre, an area where it is recognised that there is a problem with the impact of alcohol on public nuisance, particularly with regard to street drinking. The Metropolitan Police have received reports that the premises in concern have been providing drinking cups with alcohol purchases to street drinkers, in turn facilitating anti-social behaviour in the area.

4. The protection of children from harm

- Evidence submitted by the Metropolitan police reveals that there was found to be a child selling alcohol unsupervised at the premises, and a test purchase where a 15 year old was able to successfully purchase alcohol at the premises without any challenge.
- More than 40% of children who start drinking in early youth will go on to abuse alcohol/become alcoholics later in life, and underage drinking is associated with other risky behaviours such as teenage pregnancy and youth offending¹⁰. It is therefore of paramount importance that we protect our youths from the harm associated with the illegal selling of alcohol to those underage.
- The population of Figge's Marsh is different to other wards in Merton in that there are a higher proportion of young people (0-29 years) living in the area. The premises in concern is also situated within walking distance (400m) from three local school, and is likely to be on the route to and from school for children.

Conclusion

The premises in concern have failed to display that they are a responsible retailer, and have participated in, and facilitated, numerous unlawful engagements. In conjunction with the evidence revealing serious concerns about alcohol harm in the local population, we believe that the licensed premises are not running at a level where they can prevent crime and disorder, assure public safety, prevent public nuisance, and protect children from harm. Therefore, we request that the Premise License LN/000000704 be revoked as soon as is possible.

At 1735 hours a 15 year old boy accompanied by Trading Standards Staff visited the premises. The boy purchased a 325ml bottle of Guinness beer. He was served by the serve

When officers spoke to denied all knowledge of the sale but subsequently recalled events following a conversation with the DPS Mr Ronak Patel.

Four previous test purchases had been undertaken at the premises in 2010, 2011 and 2013. On each occasion a sale was refused. Mr Ronak Patel had owned the business for a number of years however; I understand that he has now leased the shop premises to a different business but remains as DPS.

The sale of alcohol to young people can lead to serious health and anti-social behaviour issues. Young people who start drinking alcohol before age 15 are five times more likely to develop alcohol abuse or dependence than people who first used alcohol at age 21 or older.

For the above reasons, and those highlighted in the review application, the Trading Standards Service fully supports this licence review.

Having regard to all the circumstances highlighted in the review application the Trading Standards Service would respectfully request that the Licencing Committee consider revoking the Premises Licence.

I have also had many complaints from residents living in nearby roads, that street drinkers regularly gather in their streets, causing antisocial behaviour by noise, littering and urinating in the streets. We have had problems with street drinkers around the Fair Green, Three Kings Pond and Mitcham Common for some years now, and this is fuelled by the many outlets selling alcohol in the area – often till late at night.

I would therefore support a full revocation of the licence at the Review Panel.
