# **Recommendations:**

That the Cabinet Member considers the issues detailed in this report and

- A) Notes the results of the review and the Experimental Traffic Management Order used to the implement the LTN in Commonside East/Grove Road/Spencer Rd aimed at removing rat running, reduce speed of traffic and to encourage safer walking and cycling. Please see plan in Appendix 1.
- B) To consider all the representations received (as set out in appendix 2 and 4) and agrees to proceed with making the LTN permanent by making the permanent Traffic Management Order.
- C) Agrees to exercise his discretion not to hold a public inquiry on the consultation process.

# 1. PURPOSE OF REPORT AND EXECUTIVE SUMMARY

- 1.1 This report presents the results of the review and the Experimental Traffic Management Order on the implementation of the LTN in Commonside East/Grove Road/Spencer Rd aimed at removing rat running and to create a better environment for the local residents. Please see plan in Appendix 1.
- 1.2 It seeks approval to make the LTN permanent.

#### 2. DETAILS

- 2.1 In response to a green recovery, DfT / TfL provided funding (subject to a bid process) to boroughs to consider, consult and implement LTNs on a number of identified routes. These routes were identified by some residents and / or were previously known to be popular rat runs particularly during the peak periods.
- 2.2 A low traffic neighbourhood (LTN) is considered within a residential area, bordered by main roads (places where buses, lorries, non-local traffic should be), where "through" motor vehicle traffic could be discouraged or removed. Strategic road closures (bollards or planters) or banned movements prevent through traffic whilst maintaining access.
- 2.3 As part of the LTN programme, during trench 1 of the funding process, the Council was successful it its bid to DfT/TfL in securing funding to design and implement a LTN on Commonside East/Grove Road/Spencer Rd. However, due to extremely tight deadlines set by TfL/DfT, this LTN was introduced under an Experimental Order. As per legislation, the Council does need to make a decision no later than 18 months of the ETMO coming in to effect.

### 3.0 SCHEME

- 3.1 The scheme was introduced in September 2020 under an Experimental Traffic Management Order (EMTO) which enables the implementation of a scheme during the statutory consultation stage. An Experimental Order allows the restrictions and the Order to be in place for a maximum of 18 months before a final decision is made. Anyone can make a representation within the first six months (the statutory/formal consultation period) of the Experimental Order coming into force.
- 3.2 The EMTO allowed the Council to meet its extremely tight deadlines but more importantly, it enabled the residents and other road users to experience the restrictions, thereby allowing them to make an informed decision prior to responding to the consultation. Consultees had 6 months to respond to the consultation and residents were encouraged to allow sufficient time to experience the scheme before making representations.
- 3.3 The initial road closures included free standing planters, lockable removable bollards for use only by emergency services and non-motorised vehicles. The lockable bollards were subject to routine vandalism by a certain non-resident individual. This stopped when ANPR was introduced.
- 3.2 Although it is normal practice to undertake before and after surveys that can be used for an impact assessment, particularly on the neighbouring roads, due to the pandemic / lock down and a general change in traffic pattern and behavior, any survey at the time would not have yielded a true reflection of *normal* traffic something that would be required for a meaningful before and after comparison. Notwithstanding this, Tamworth Lane and Grove Road are both local Distributor Roads; both are bus routes and primary emergency routes and therefore all traffic including all local traffic should use these roads rather than attempting to cut through this section of Commonside East.

#### 4. CONSULTATION

4.1 The consultation on the LTN began on 7<sup>th</sup> September 2020 and concluded in March 2021. Newsletters were delivered to 334 properties within the catchment area (see plan in appendix 5). The newsletters detailed the consultation process; the proposed measures and a location plan. A copy of the newsletter with the plan for each LTN is attached in Appendix 1.

- 4.2 Residents were encouraged to submit their feedback on the Council's website using specific on-line feedback links; however, it appears that many made their representation shortly after the implementation of the scheme which did not allow them sufficient time to experience the improvement. All available information was also posted on the website.

  <a href="https://www.merton.gov.uk/covid-19-transport-projects">https://www.merton.gov.uk/covid-19-transport-projects</a>. Street notices were erected on lamp columns and published in the local papers and the London Gazette.
- 4.3 After removing blanks and those without an address and combining multiple entries from the same person, the statutory consultation resulted in a total of 73 representations. There were 36 representations from within the catchment area which represents 10.8% of the consulted catchment area. There are 15 in support the scheme and 21 objections. This means 6.29% of those consulted object to the scheme. There is one additional representation which appears to agree to the scheme but with a negative comment. The majority of objections are based on inconvenience because of increased in journey times; congested traffic on the main roads increasing pollution; concerns for the emergency services. There were 30 objections, 7 support and 1 unsure from outside the consulted area. All responses are detailed in appendix 2.
- 4.4 It is essential to note that when making a decision based on the outcome of a statutory consultation, consideration must be given to the validity of objections rather than the number of objections. Additionally, although the on-line feedback link did ask views in terms of level of agreement and disagreement with regards to the scheme, within a statutory consultation, objections are invited and should be given due consideration. Although an assumption cannot be made in terms of level of support from many who did not participate within the consultation, a low response rate could be considered that majority do not object to the scheme. In this case, during the statutory consultation, 6.29% of consultees objected to the scheme.
- 4.5 All statutory bodies were consulted. Emergency Services did raise concerns regarding the use of lockable bollards that would impact their response time. At the time, funding was not available for ANPR camera enforcement; however, due to ongoing concerns raised by the Emergency services across London where many local authorities were also implementing LTNs, TfL / DfT agreed to provide the funding required for ANPR cameras. The use of an ANPR camera simply means a change in nature of enforcement which facilitates concerns and objections from Emergency services. Following a successful bid for additional funding, the Council was able to secure the necessary ANPR cameras which were installed. This addressed the objections and concerns raised by the Emergency services and some of the residents. The objections based on emergency access as raised by some residents can therefore be considered as addressed and thereby overruled. Those objections regarding mopeds in contravention of the LTN can also be overruled as this is also enforced by ANPR cameras.
- 4.6 Following the completion of the statutory consultation in March 2021, during June / July 2021 the Council carried out a further engagement with the residents via a questionnaire. In June 2021 a newsletter was delivered to all the properties within the catchment area and residents were asked to complete a simple on line questionnaire. Hard copies were also made available upon request. A copy of the newsletter is attached in appendix 3.
- 4.7 After removing blanks, multiple entries and those without an address, the outcome of the review / questionnaire resulted in a total of 72. There were 58 from within the catchment area representing a response rate of 17% of which 23 support the scheme, one unsure and 34 against. The majority of objections are based on inconvenience because of increased in journey times; congested traffic on the main roads increasing pollution; concerns for the emergency services. All responses are detailed in appendix 4.

- 4.7.1 As already mentioned, the outcome of this type of consultation is based on comments i.e. the reasons for resident's objections. Although the majority of those who responded do not support the scheme, after a closer analysis of the comments, it is clear that many consider the inconvenience of a longer journey is not acceptable and despite the fact that the posts have been removed, some residents continue to consider the LTN as a hinder to emergency access.
  - 4.8 The local Ward Councillors have been engaged during the consultation process. The results of the consultation and officer's recommendations were presented to the Ward Councillors prior to preparing this report.

# 5. OFFICER'S RECOMMENDATION

5.1 When considering the outcome of the statutory consultation and the review feedback, consideration must be given to the nature and validity of the comments / representations and the Council's objectives. Given the extremely low response rate during both the statutory consultation and the review and the nature and contents of the comments received vs the overall benefits, it is recommended that the LTN is made permanent. It is considered that the benefits outweigh some of the inconvenience some residents may experience. This scheme is in line with other policies and initiatives across the borough and London which is believed to be the right step forward in changing road user behavior as well as the general environmental benefits.

#### 6. ALTERNATIVE OPTIONS

6.1 To remove the LTN will result in an increase in volume of traffic through these roads; an increase in speed and will do nothing to meet the Council's various objectives in terms of improved air quality and environment.

### 7. TIMETABLE

7.1 A newsletter detailing the results of the consultation and Cabinet Member decision will be distributed to all the consultees soon after a Cabinet Member decision is made and published. The permanent Traffic Management Order will be made and published soon after.

# 8. FINANCIAL RESOURCE AND PROPERTY IMPLICATIONS

8.1 All the associated costs are covered by the LSP and LiP funding provided by DfT / TfL.

#### 9. LEGAL AND STATUTORY IMPLICATIONS

9.1 The Traffic Management Orders would be made under Section 6 and Section 45 of the Road

Traffic Regulation Act 1984 (as amended). The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft order.

- 9.2 The Council has discretion as to whether or not to hold a public inquiry before deciding whether or not to make a traffic management order or to modify the published draft order. A public inquiry should be held where it would provide further information, which would assist the Council in reaching a decision.
- 9.3 The Council's powers to make Traffic Management Orders arise mainly under sections 6, 45, 46, 122 and 124 and schedules 1 and 9 of the RTRA 1984.

#### 10 HUMAN RIGHTS & EQUALITIES AND COMMUNITY COHENSION IMPLICATIONS

- 10.1 The Council carries out careful consultation to ensure that all road users are given a fair opportunity to air their views and express their needs.
- 10.2 Bodies representing motorists, including commuters are included in the statutory consultation required for draft traffic management and similar orders published in the local paper and London Gazette.

# 12. RISK MANAGEMENT IMPLICATIONS

- 12.1 The risk of not acting in line with the majority feedback could lead to dissatisfaction amongst the objectors.
- 12.2 The risk of not doing anything would be that volume of traffic and speeding traffic will increase; it will not address all the various objectives regarding improved air quality and safer improved environment.

#### 13. ENVIRONMENTAL IMPICATIONS

13.1 The removal of rat running / reducing volume of traffic will ensure a reduced road safety risk; a better environment for residents and vulnerable road users; a reduction in noise and pollution.

# COVID-19 - LOW TRAFFIC NEIGHBOURHOODS (LTN) COMMONSIDE EAST NEAR ITS JUNCTION WITH SPENCER ROAD EXPERIMENTAL ROAD CLOSURE

#### **Proposed Road Closure**

As part of Merton's response in maintaining social distancing, removing rat running and to encourage safe walking and cycling, we will be introducing a temporary road closure on Commonside East near its junction with Spencer Road. The proposal will include free standing planters, lockable removable bollards for use only by the emergency services and authorised vehicles..

#### **Consultation process**

The proposed measure is being introduced under an Experimental Traffic Management Order:

- This allows the Council to implement the restrictions during the consultation period.
- It allows the Council to assess and monitor the restrictions and its impact.
- It will enable the residents and other road users to experience the restrictions, thereby allowing them to make informed comments.

The restrictions and the Order will be in place for a maximum of **18 months**. Anyone can object and make representations within the first six months (the statutory/formal consultation period) of the experimental Order coming into force and the implementation of the works. Consultees (mainly residents) are encouraged to make their comments at least 3 months <u>after</u> implementation. Consultees will have 6 months to respond to the consultation. All representations will be considered prior to making a final decision which could include its removal, making any necessary modifications or making it permanent.

Street notices will also be erected within the vicinity of the proposals to inform residents and road users of the start of the restrictions and the statutory consultation.

All available information including updates will be posted on the website. All representations must be made on line using the following link. Please note that you may not be able to submit any comments until end of September 2020 <a href="https://www.merton.gov.uk/covid-19-transport-projects">https://www.merton.gov.uk/covid-19-transport-projects</a>

A response **will not** be made until the consultation is concluded and a final decision is made. The Council will monitor the situation and will make the appropriate adjustments if and when necessary.



There are many seniors in Spencer Road, including my lodger, who have mobility issues and the constant through traffic over these years has been dangerous. There have been multiple near misses and numerous damaged cars, all done by drivers with no regard to anyone's safety - because they are too lazy to spend a few extra minutes choosing another, wider route. As long as the emergency services have complete access, it would better if these temporary measures were to become permanent.
6291232		Having the restriction in place has been wonderful. The 'rat-run' of Spencer Road has ended, and residents no longer have their vehicles damaged or their pets killed. (There was criminal damage done to the restriction bollards, but fortunately the Police have identified the two individuals). It would be ideal if we could have one or two more planters in place, instead of the bollards. The emergency services have been using the wider roads of Tamworth Lane and Cedars Avenue, which is quicker for them. The only other vehicles that use the Spencer Road Junction are Veolia, but that is only once a week, and surely they could adjust their route? This restriction is a good thing!!
Spencer Road 6283847 6291647	Agree	The scheme has turned Spencer Rd from a busy rat run with constant high speed traffic into a quiet, peaceful residential road. Wonderful. Having had a car damaged, another written off, and been knocked over (thankfully only minor injuries) by speeding rat runners over the past several years I am extremely happy that the council has finally taken action to improve the road I live on. The benefit massively outweighs the small extra time

needed on the occasions I need to use my car. This scheme has made a huge difference, for the better, to living in Spencer Road. I have lived here for over 25 years and have seen the steady increase in the amount of traffic in the road. This is a narrow one way street not built for the amount of traffic that comes though here. It has become a rat run over the years. The chicanes that were put in many years ago, do not slow the traffic down and drivers using this road as a rat run would speed through. Traffic was always continuous during rush hour and busy even at the weekend. Parking was always hazardous as you would more often than not have someone, in their car, right behind you as you manoeuvre. They would then get impatient, sound their horn and a cars waiting would pollute as they were waiting. My husband was once knocked down by a van using this road as a rat run. He was walking home from the train station and he ended up in A&E in St. George's. We have also had a car written off; been rear ended and also had a wing mirror taken off. Neighbours have had similar incidents with their cars. It is now so much quieter in the street, which makes a huge difference, as our house is not set back far from the road. Without the number of cars cutting through our road the pollution has gone down too and I have seen several cyclists enjoying using the road now instead of sometimes going up on the pavement to get away from the cars. I wish this scheme had happened when my children were growing up here and using their bikes. I also feel that there may be less people using this road as a carpark for the station, which is great as there aren't enough parking spaces for the residents. I really hope this becomes permanent. Sometimes a bollard goes missing so that needs to watched. Spencer disagree Dear Sir/Madam, As resident of Spencer Road who is directly affected by this scheme, I Road do not see the necessity for the blocks in order to allow space to social distance as in my experience there has been ample space to socially distance whilst walking before the Submitted blocks were put in place. In addition, the blocks significantly increase the amount of time twice taken for our daily commute into school and work affecting our concentration, especially 6250651 for my brothers. Before the blocks were put in place, I have never felt that the cars that 6250641 may use Spencer Road as a 'through' route were causing an issue to the neighbourhood; there was rarely any congestion/traffic on the roads and having some cars pass through the neighbourhood in fact helped me, as a resident, to feel safer as there were more people around in case of muggings or ambushes, which I know have happened on our road before. However, after the implementation of these blocks, I worry that Spencer Road has become very isolated and secluded which I believe may be a bigger danger. more relevant to this neighbourhood than the threat of road danger due to the existence of the through road. I think a different approach to increase physical activity would be better as the blocks interfere with commute times where it may not be the most convenient, for example, due to the distance of their school it is not possible for my brothers to walk/cycle to school however they love to practice football afterschool but due to the blocks they get home later leaving them with much less time to do so. I hope you

consider my points and make the decision to remove the blocks in due time. Thank you.

Spencer Road  2 submissions from same person 6283903 6307450	Disagree	The scheme has just aggravated the traffic problem existing in the area conveying all the traffic to one single road (Tamworth Lane) that with the train station isn't prepared to receive so much traffic. Also the area doesn't see that much traffic outside peak hours. This decision is wrong and should have been taken after consultation with the neighbourhood and not before.  The restriction hugely impacts on traffic in the area at peak times, causing stationary traffic for long periods of time impacting on the environment in the area. I think that if there's safety concerns using humps can be a nice way of preventing speeding
Spencer Road 6249216	Disagree	This road blockage has been implemented without consultation and consideration for the impact on the local residents and businesses. Whilst I understand the rationale for these projects, the means by which they are implemented is not effective and has not been thoroughly investigated. The reasons being: 1. The traffic on Commonside East and Tamworth Lane, as well as all roads leading to and from Mitcham East, have been severely affected and this area was already highly congested. 2. Residents who have children, particularly those with physical disabilities, are severely disadvantaged by this measure due to the increased traffic and the time it takes to get to and from school. This impacts on pollution levels, parental stress and school readiness and all this, at a time when we as a society are already going through substantial disruption. 3. There is an increase in the number of vehicles driving around the one way system that leads to Spencer Road as they attempt to exit on to Commonside East, causing frustration for drivers, increase pollution and traffic on this road and difficulties maneuvering, particularly for larger vehicles. 4. # **REVIEW OF LOW TRAFFIC NEIGHBOURHOOD (LTN)**

Dear Occupier,

As you are aware, during September 2020 the Council introduced a Low Traffic neighbourhood scheme on Commonside East under an Experimental Order. The 6-months statutory consultation closed in March 2021 and we are currently considering all the feedback received.

It is appreciated that some residents had concerns and some reservations when the LTN was first introduced particularly during the settling down period, but it is hoped that despite some minor inconvenience to some residents, many of you have come to enjoy and acknowledge the benefits.

Some concerns were also raised regarding access for emergency services and the routine vandalism which has been resolved by the installation of an ANPR camera.

Before making a final decision, it has been agreed to undertake a review of the scheme. As part of this review, we are asking you to submit your views to a simple on- line questionnaire using the https://consult.merton.gov.uk/survey/857 on the Council's website.

Those who do not have access to a computer, can call 020 8545 3700 and ask for a hard copy of the questionnaire and one will be posted to you.

The deadline for submission is **2<sup>nd</sup> July 2021**. Please note that it is only one submission per household and as part of this review individual responses to comments will not be made.

The Cabinet Member will make a decision based on the feedback received during the statutory consultation and the outcome of this review. Your participation within this review is, therefore, important.

You will be informed of the Cabinet Member decision once a final decision is made.

And also may I say I have seen the police use it to their advantage when cars turned down the road and I can't get back out. Thank mark.
Acacia Road 6338655	Yes	much more peaceful now the rat run is closed. My car used to get covered in scratches usually due to 'white van man' doing 30+ mph down the road trying to beat oncoming traffic
Brenley Close 6338920	No	We have lived here for over twenty years and have never had an issue with using this road to access our property. This is so unnecessary as its already a one way system, now it has now caused us to be on the road longer, especially when traffic. When my wife finishes late at work and cant park on our close she has to then drive all the way around to park on the other side of the bollards. You have now installed a camera to gain revenue, yet you are unable to install CCTV for fly tippers in this area - What does our opinion matter, do do what you want?
Brenley Close 6339305	No	the scheme has caused more traffic to come down our close simply for turning purposes. Children play outside and cars fly down the road to turn. I would also add that my mum lives in Spencer Road which is the next road along. She is 91 years old and needs constant attention. I used to be able to drive there in 2 minutes if needed but now i have to go all of the way around Cedars Road, back down Acacia Road and back to where I started! The restrictions have not eased the traffic flow at all in this area and indeed, people are parking in front of the barriers at night and therefore, there would be no access at all for the emergency services. It is unsightly and could possibly be a death trap if the emergency services are unable to access.
Commonside East 6339398	No	Just slows things down; delivery drivers having to drive 1/2 mile out of the way for next delivery, takes me twice as long to get to the local shops or chippy as before, and recently seen lots of cars simply driving through it as one of the posts keeps getting vandalised (unsurprisingly). But still lots of cars an loud bikes driving along the roads, so it isn't really achieving much beyond annoying people.

My only concern would be the increase in traffic in Tamworth Lane and the need when return from Mitcham fair green to go this way and the increased congestion. A small price to pay but one that needs monitoring by the council.

Grove Road 6339334	Not sure	- It has stopped drivers speeding through Spencer Road and Grove Road to cut the corner off their journey. It has reduced traffic and created a safe space for people to walk. I have noticed many more people cycling and walking down Grove Road making use of the new cycle path section that joins the roundabout. There are also some children in Grove Road that have been out cycling in the road which was never previously possible due to the high frequency of drivers that were using Grove Road and Spencer Road as a cut through  I am not sure about the low traffic, the traffic is not a problem to me. I work from home and there are times when I have to pop out in my car, and I find it very annoying that I have to make a longer journey that only takes 5 minutes. I feel a lot of people feel better about traffic control but that really doesn't bother me. I am more concerned about quick fast journeys which safes me a lot of time and effort and petrol. I live on Grove Road and at the top of the road people are always dumping rubbish massive furniture parts and all sorts I will be happy
		for my street to be cleaned up not to worry about traffic. What about putting a camera there to catch the culprits that would be better for me. Grove Road needs to be cleaner. My preference is to have the road reopened so I have easy access to go to Mitcham town center and other areas Croydon etc, its just ridiculous. And also going to Acacia Road one still get stuck in traffic. It would be good to revert the road as it was.
Grove Road 6339939	No	The blockage has made it difficult to drive in this area. By having to drive via Acacia road and onto the main road where the train barriers of Mitcham eastfields station cause traffic. Furthermore, by reducing the traffic, we have noticed the fly tipping issue at the corner of Grove road (joining onto Spencer road) has become more frequent often resulting in road blockages, and simply a messy corner where rubbish flies around. Despite requests and petitions from the residents to the council to add a camera here to avoid this this had not been actioned. The corner is poorly lit and as it is a blind area, it is not the safest. Previously, traffic would at least deter any wrongdoers.
Grove Road 6339370	No	the diversion in Spencer Road creates more traffic in Cedars Ave
Grove Road 6338466	No	I'm not happy with the changes as there is now only one access through to my road which means I have to sit in the traffic queuing for the eastfield train crossing. Also when I leave my house I'm always cought up in the queuing traffic from the school and train crossing. I think it's causing more traffic on the road where the eastfield train crossing is therefore putting more cars and considerable congestion which has the adverse effect. I would like the scheme to be scrapped.
Grove Road 6339757	No	It has caused increased wait time by 5x its original and has caused traffic to neighbouring roads/areas.
Grove Road 6341172	No	It has caused severe traffic congestion in the surrounding area at busy times. This has caused a great deal of stress to me and my family because we have children who need to get to schools in the mornings. At busy times from the junction of Grove Rd and Commonside East it can take up to forty minutes to complete the journey home. Before the LTN this would have been a three minute journey along Stanley Rd and Kings Rd. All traffic is now directed to Cedars Avenue and Tamworth Lane where the railway crossing contributes to huge delays. In this aspect the LTNs have surely failed to address climate concerns. Cars sitting in traffic jams for long periods of time generate more pollutants than they would have done. Restriction s on traffic outside St Thomas of Canterbury at the same time as the introduction of the LTN. There is now no safe place to stop to drop off children. As a consequence I have now paid hundreds of pounds in fines because of these two measures. The bollard was removed permanently earlier this year. At the same time that the camera was introduced. This seems to be another cash cow for Merton Council. It is disingenuous to claim that it has been out there to stop vandalism. I have lived in Grove Rd for 15 years and just beyond the filed of view of the camera at the end of Grove Rd is a favoured fly tipping spot that has caused great distress for residents over the years and continues to do so, on occasion blocking the road completely. Is this not a form of vandalism? The nature in which this was introduced was not in keeping with democratic rule. The initial notification of the LTN was given with very little notice. It included unsubstantiated claims that it would help with social distancing measures. Please do provide further details of this. The prediction that traffic would evaporate has not

		happened. Traffic did reduce because of lockdown but now the queues are worse than ever.
Grove Road 6340803	No	Allow local residents to drive through the LTN ju  Absolutely disgusting to restrict our access. Grove Road was low traffic and low speed traffic road anyway. You are spending our money (to be precise 5.9% more than last year) on cameras and planters that don't have any real value apart from making my journey home tortuous. It would be great if I was stay at home mum and walked my child to nursery however I work full time and have to drive. It is particularly pleasant when I bring my tired screaming child back from nursery and the traffic has build up due to the barriers at the station so I have to queue because I can't turn into Acacia Road which I the ONLY entrance to Grove Road!!! You have no care for working families. I am considering moving out as can't keep spending extra 20 to 30 mins a day in traffic due to you decision. Please make me an offer and buy my house for council housing, only pensioners and council housing residents (who do not work, not the working ones!! Anyone that need to leave the house won't be able to cope with this). I work full time and have young child so that leaves me with very little personal time for rest or development. Selling and moving to reasonable area will give me minimum of 2h per week back, 8h per month which will help me rest more and investment in further qualifications. This ruined my quality of living in the area, if this was in place when I was buying the house I would have NEVER spent my money here!!!
Grove Road 6338656	No	It has caused long delays. With the traffic from the train crossing and schools you have made a mistake doing this. It hasn't stopped fly tippers at all it's just grid locked the whole area I can't do school run as takes too long and long delays getting to work
Grove Road 6339131	No	Rather than low traffic schemes hook a tram link down Red House Road through Wagner's Road and along Commonside. This would decimate traffic.
Grove Road 6339893	No	As a local resident who lives adjacent to an exit from Mitcham Eastfields station, I believe the scheme to be overall more detrimental to the environment than before. The rat run traffic you are targeting is merely displaced onto Tamworth Lane, Cedars Avenue and Acacia Road. I regularly see traffic chaos at the junction of Tamworth Lane and Acaia Road causing long tailbacks of cars idling and producing excess emissions. Delivery vans have all taken to reversing (at speed) into our road to avoid going all the way round. Emergency vehicles also being delayed.
Kings Road 6338853	No	Hello I'm on kings road and closing the top of spencer road as you have now means we have to drive in a spiral to get onto this road as the whole thing has been one way for years coursing the traffic to follow the road round and it has worked very well, right up until this was added. now as well as all the added distance we now have to drive just to get home each day the extra traffic that is now pushed onto roads like Tamworth lane and Cedars Ave just to sit there pumping out fumes which seem to me rather counterproductive.
Kings Road 6340680	No	My entire household is against the Low Traffic neighbourhood scheme on Commonside East. The closure to motor vehicles on the road leading to Spencer Road has caused issues to not being able to access residential area. We have a vulnerable child so access to this road is crucial. In addition, emergency vehicles such firehouse engines and ambulances do not have

		access so this makes it more difficult. There are times when the road is closed off when trains are passing by which can be anywhere from 5 minutes to 30 minutes if there are multiple trains and this also affects access to the commonside east area which is detrimental. When considering this decision, we ask that you take in account the vulnerable persons and residents of Spencer Road and Kings Road. Imposing the low traffic scheme would affect all residents. Residents in Spencer Road have been for years having to put up with this intolerable situation. I have over a period of time witnessed many accidents and dangerous driving incidents at the junction of Grove Road/Spencer Road which in my opinion could have been fatal on many occasions. Spencer Road 6339690	Yes	The scheme on our road has made it much safer. It used to be a 'rat run' through to Streatham. but since the barriers have been installed the road is much quieter and safer for families with young children and dog walkers using the local part. It also feels more like a community. As Spencer Road is a narrow road it has made it much easier to park without the pressure of a build of traffic taking a short cut through.
Spencer Road 6338581	Yes	I'm completely in favour of the scheme as it's eliminated a great deal of rat run traffic in Spencer Road. However, Spencer Road still suffers from many drivers at very high speed, as fast as they can go, undeterred by the few narrow sections. Spencer Road 6338522	Yes	The No Entry from Grove Road into Commonside East could be lifted to one way for access to C/East as at the moment you have to drive down Spencer Road to the end of Acacia Road to turn right into traffic onto Tamworth Lane where a road is opposite and other vehicles are trying to get across or joining traffic onto the main stream, you have traffic waiting to go to Eastfields station, traffic due to Crossing Lights, and traffic waiting to turn right into road you are trying to get out of, it is very dangerous!!
Spencer Road 6338909	Yes	It had been an accident-prone area before the introduction of Low Traffic Neighbourhood on Commonside East. Now it is a quiet and accident-free area. Effective CVTV will bring about more safety.
Spencer Road 6339950	Yes	It's very good It has made our road safer as it is now not a rat run. Vehicles, mirrors in particular are not getting damaged.
Spencer Road 6338631	Yes	It has made Spencer road a peaceful joy to live in. It has stopped the cars and bikes speeding down the road using it as a rat run. Residents cars were continually being damaged by hit and run drivers. Parking has become easier. It has alleviated Sat Nav's sending lorries down a road that was not suitable for HGV's and they were getting stuck at the Kings Rd end of Spencer Rd. Spencer Road 6340127	No	Adds unnecessary time on a journey. Pushes all the traffic towards the level crossing and for us only being able to exit via Acacia Rd/Tamworth lane crossroad, causes more issues than needed. Very disappointed we were not consulted about our opinions before it was placed.
Spencer Road 6338456	No	I don't think it is necessary to have this road blocked off, it has caused a lot of traffic issues for residents. I don't believe there was a huge amount of traffic when this road was open and i haven't heard of any accidents so i am not sure why this was even considered. it is a huge inconvenience to residents that i have spoken too
Spencer Road 6338413	No	It puts and extra 20 mins per day on my commute to and from work
Spencer Road 6341780	No	No consultation before putting it in, you have forced more traffic on to main roads, causing more pollution, there are 3 schools very near by, this is not good for the children, the only access is one way very narrow road, deliveries are finding it hard to deliver, only route out to the level crossing road, very difficult, when level is down, road works on this said road, temp lights have been a nightmare, residence should have access to this road. its been done in other boroughs. Spencer Road 6338599	No	It is inconvenience I have had too call an ambulance in was horrible waiting time and push more traffic in mitcham
Spencer Road 6338916	No	Add more traffic to carers Road and Tamworth Lane adding sometimes half an hour add to journey if the barriers are down at eastfild Station also a member of the taxi scheme card service which adds more expenses onto an elderly person and add pollution to the aera I have lived in Spencer Road for 47 years and had no problem with traffic
Spencer Road 6338411	No	Emergency access to our homes is restricted. Have had to call the police and ambulance before and those extra minutes they take to reach us are crucial. Also haven't really noticed a difference in traffic outside our homes, only very occasionally when the barrier was down by Mitchan Eastfields Station, but it's barely noticeable
Worcester Close 6342649	Yes	Has made life much better with no rat running in Acacia Road although some kind of controlled parking is still needed for railway station traffic using free parking, perhaps even 11-1 daily
Worcester Close 6339031	Yes	I have found the scheme to be a vast improvement on previous arrangement. The route, prior to the closure of Commonside East, was unsustainable in terms of congestion, pollution and above all road safety. With cars parked both sides of the road and traffic bumper to bumper in either direction which could only move in a single lane has made crossing the road extremely difficult with the addition of cyclists weaving in and out in an attempt to make their way through the traffic. Given the circumstance it was only a matter of time before thee was a serious accident. In view of the above the current arrangement has proved to be a very satisfactory solution in all respects and I and my neighbours very much hope that this arrangement will continue.
Worcester Close 6338607	No	I object to LTN because it's going to make traffic jam worse on the main road. Traffic jam with engines on pumps a lot of emission to the air. Also taking away the opportunity to have road diversion, and I have general concern of access for emergency services vehicles

Worcester Close 6338579	No	Traffic
Worcester Close 6341025	No	Since the low traffic scheme Tamworth Lane has traffic back up and running engines creating more pollution. My journey from work used to take 10 mins max now I frequently wait in traffic 20-30 minutes when the barriers are down. The number of cars turning in my driveway has increased dramatically. It is the pollution that this scheme has caused making people wait so long in congestion that before was not a problem.
Worcester Close 6338409	No	Under this scheme all traffic leaving Kings Road, Spencer Road, Acacia Road, Grove road and Worcester Close is forced to exit into Tamworth Lane causing extreme congestion especially when Eastfields level crossing is closed and during rush hour. This also causes heavier traffic into cedars avenue. In addition, when Tamworth Lane was closed for repair work there was absolute chaos as all traffic had to divert over the level crossing or go towards Streatham. Being able to leave and return via Commonside East would have alleviated these problems. As there is an ANPR camera now in situ perhaps only residents that have registered their number plates in the aforementioned roads could be allowed through. This also may help to stop possible fly tipping in Grove Road.
Worcester Close 6338408	No	There was no consultation before the closure of the road, the opinions and views of all residents were not taken onto account. This closure causes considerable delay at certain times of the day due to the level crossing and build up of traffic in Tamworth lane. The top of Acacia road is often blocked meaning residents affected by the closure are unable to enter or exit Acacia, the only way to access Worcester Close and the surrounding streets. Residents are using more petrol, more fumes in the air and a lot of time sat in a traffic jam which at times winds around the corner into Cedars Avenue. Very frustrating to have only one entrance and exit and I am concerned if I had a personal emergency that I would not be able to leave.
