4 APPOINTMENT TO THE POSTS OF DIRECTOR OF CORPORATE SERVICES AND DIRECTOR OF ENVIRONMENT AND REGENERATION (Agenda Item 5)

Introducing the report Richard Mycroft advised that the person recommended for appointment to the post of Director of Corporate Services had confirmed that she would accept the post.

In agreeing the selection panel for appointment to the post of Director of Environment and Regeneration it was noted that Councillor Chris Edge was yet to be appointed to the Appointments Committee and recommendation B was amended accordingly. It was also noted that Councillor Edge would receive equalities training prior to the interviews.

The Committee expressed concerns about elements of the process used in appointing to these posts and Richard Mycroft apologised for mistakes in the administrative arrangements. He emphasised that steps were being taken to codify what was a complex process.
