## 1 PURPOSE OF REPORT AND EXECUTIVE SUMMARY

- 1.1. The South London Waste Plan (also known as the Joint Waste Management DPD) is being prepared jointly by the four boroughs of Croydon, Kingston, Merton and Sutton. If adopted in 2012, it will become part of each borough's Local Development Framework, setting out the planning policies and potential sites on which waste management facilities will be considered across the four boroughs.
- 1.2. Appendix A of this report is the final draft of the South London Waste Plan. It will be published on Monday 04 October and will be circulated separately to Advisory Committee Members by post or courier by Wednesday 06 October. The final draft of the South London Waste Plan has been created following three years of preparation, including more than six months of public consultation. The Waste Plan is now being considered by each of the Cabinets and Councils of the four boroughs, seeking their recommendation to submit it to the Secretary of State for independent examination.
- 1.3. The Borough Plan Advisory Committee will receive a report on the Waste Plan at the meeting on 4<sup>th</sup> November, recommending that the Waste Plan be considered for submission to the Secretary of State, via Merton's Cabinet and full Council. As the Waste Plan is a long document, it is being circulated here for information to enable informed consideration in November.

# 2 DETAILS

- 2.1 Following consultations on the 'potential sites and policies' (July October 2009) and 'Additional Sites' (February March 2010), the South London Joint Waste Development Plan Document (South London Waste Plan) has been updated.
- 2.2 The policies by which future applications for waste management facilities will be assessed have been strengthened in response to comments from

residents and other stakeholders. With regard to site allocations, the Waste Plan now proposes to safeguard existing waste management sites and permit development on a further seven hectares of land (not currently in waste management use) from amongst existing industrial areas across the four partner boroughs.

- 2.3 The cross-party Joint Waste Plan Members Working Group have been guiding the project since its inception. Cllrs Ian Munn and Maurice Groves are Merton's representatives. They have now recommended that the Waste Plan be circulated to all partner boroughs seeking their recommendations to submit the Waste Plan to the Secretary of State for independent examination.

- 2.5 The proposed submission version of the South London Waste Plan is attached as Appendix A to this report. The Waste Plan will contain the policies by which future applications for waste facilities will be determined and identify the sites and areas within which waste development will take place over the initial lifetime of the Waste Plan (2011 to 2021).
- 2.6 The next stages of the Waste Plan's progress are shown in Table 1:
