- 2.2. It is proposed to amend Part 3F paragraph 5(i) to replace "Director of Environment and Regeneration" with "Director of Corporate Services".

- 3.1. The Audit Commission is no longer our external auditor so references to the Audit Commission need to be amended to read "the Council's external auditors"
- 3.2. It is proposed to amend Part 3B paragraphs 1.1(c)(i) point 4 (Standards Committee terms of reference) and 1.7(b)(iii) (General Purposes Committee terms of reference) accordingly.
