1. EXECUTIVE SUMMARY AND PURPOSE OF REPORT

1.1 The report provides information for Members regarding the Licensing Section's structure and staffing levels; working arrangements and outturn; achievements and performance in respect of the Licensing Act 2003; financial status; an outline and timetable for the pending responsibilities under the Gambling Act 2005.

2. DETAILS

Structure

- 2.1 Before the introduction of the Licensing Act 2003, the Council's licensing functions were carried out by one Officer who was attached to the Housing and Pollution Section.
- 2.2 The new Licensing Section's structure is now fully established with 6 staff, consisting of a Section Head, Principal Licensing Officer, Licensing Officer, Licensing/Specialist Gambling Officer, Senior Administrative and Finance Officer and an Administrative Assistant.

<u>General</u>

2.3 The Section continues to undertake all the traditional licensing public control functions (e.g. Special Treatments, Poisons, Animal Boarding Establishments, Lotteries etc) and the monitoring of same.

Enforcement Action

- 2.4 The Section has undertaken one successful prosecution and is currently investigating the following premises:
 - Bar Sia, The Broadway, Wimbledon In February 2006, the Manager and Licensee were convicted of several breaches of the conditions of their licence, notably the locking of a fire exit door. The Licensee was fined £2,000, the Manager £150 and costs were awarded to the Council.
 - La Sporta, Church Road, Mitcham In conjunction with the Safer Merton Joint Tasking Group, evidence is currently being compiled with a view to prosecuting the venue Freeholder, Manager and the Organiser of an unlicensed event that took place in May 2005.
 - Piano Lounge, Merton High Street Under investigation for operating in breach of the licence conditions relating to sound attenuation controls.
 - O'Neill's Public House, The Broadway, Wimbledon following a noise nuisance complaint from a local resident, an investigation is being conducted regarding noncompliance with a licence condition giving rise to sound escape from the premises.

Licensing Act 2003

- 2.5 The following provides an overview of the Section's progress in respect of the Licensing Act 2003:
 - The **Licensing Register** has been compiled and became available on 07 February 2006.
 - There have been very few complaints about licensed premises and no requests for a review of a Premises Licence or Club Certificate.
 - Work on the first review of Merton's Licensing Policy Statement will commence in March and will be reported to Members in June 2006.
- 2.6 To date (03.03.2006), under this legislation, the Section has received and processed **1,026** Personal Licence applications.
- 2.7 The perceived number of Licensable Premises in Merton is 614 and the current position is summarised below:

2.8 Since the Second Appointed Day (24.11.2005), Licensing Field Officers have detected 33 unlicensed premises and advised of the need to obtain a licence. Applications have since been received from 21 (64%) of said premises.

- 2.9 The Section has a 95% target for the determination of Personal Licences within 3 months and Premises Licences within 2 months which continues to be exceeded, the achievement being <u>100%</u>.
- 2.10 A Customer Satisfaction Survey is being conducted. 1500 enquiries were sent out in January. The analysis of the responses should be available by the end of March 2006

Gambling Act 2005

- 2.11 During 2006 and the early part of 2007, Merton Council will take on this new statutory responsibility for the licensing of premises where gambling/gaming takes place. The following outlines the timetable for the implementation of the this Act:
 - In the early part of 2006 Merton Council will initially be asked to indicate whether or not it wishes to have Casinos in the Borough.
 - May 2006 Gambling Commission to publish guidance for local authorities.
 - June 2006 Gambling Commission to publish licence conditions and codes of practice.
 - June/July 2006 Local Authority to agree Draft Licensing Policy Statement on Gambling, publish and consult upon same.
 - Late 2006 Authority adopts the Licensing Policy Statement.
 - January 2007 Licensing Authorities will accept applications for all licences and permits.
