1 DECLARATIONS (Agenda Item 1)

None advised.

2 MINUTES (Agenda Item 2)

RESOLVED: That the minutes of the meeting held on 21 October 2010 are agreed as a correct record.

3 DELEGATIONS TO THE LICENSING COMMITTEE (Agenda Item 4)

The Council's senior lawyer made a number of introductory comments and responded to matters requiring clarification.

In particular, the committee noted the requirement to include provisions in the Council's constitution in respect of delegations to sub-committees dealing with Gambling Act matters; to make reference to the procedures and hearings relating to the Gambling Act; and the inclusion of provisions relating to "other functions" (Section 7(5) of the Licensing Act 2003 refers).

The Committee also had regard to the fact that the current Licensing Committee established under the Licensing Act 2003 can only deal with licensing matters that fall under that Act and the Gambling Act. In order to deal with 'other licensing functions' the report proposed the constitution of a second Licensing Committee (miscellaneous) in order to consider the designation of streets for street trading purposes or any other licensing function that does not fall under the Licensing Committee.

Councillor Samantha George enquired as to the effect of the deletions detailed at Appendix 1 on page 9 of the submitted report. Officers confirmed that the proposed deletions amounted to an exercise in reducing the amount of narrative to an

C. the above recommendations are progressed by the Monitoring Officer as part of the review of the Constitution (Article 15.2, Part 2 refers); and

D. the proposed amended sub-committee delegations detailed in Appendix 1 to the submitted report are adopted.
