### 8 LAND HOLDINGS: PROGRESS REPORT (Agenda item 6)

Members agreed that the Board needed to consider improvements to the Board's land whether or not the current tenancy continued. A further meeting of the Board should be called to consider a report to be commissioned into the works necessary to resolve the flooding and drainage issues.

#### RESOLVED: That the Surveyor is authorised to

- 1) commission a report into the drainage and flooding issues and to bring this to a meeting of the Board as soon as possible for further consideration.
- 2) arrange mains electricity supply to Area C and associated expenditure for this up to £25,000.
- 3) serve notice the tenant to prevent contaminated water entering onto the land owned by London Borough of Sutton.
- 4) arrange a site meeting to liaise with the tenant.
- 5) arrange clearance of fly-tipping on Green Lane on a regular basis
- 6) once the estimates for improving the drainage and providing mains electricity are available to explore further with Ms Goodson the assistance required on rent payments and report the results of both matters to The Board for consideration.
- 7) to complete matters relating to the application by the tenant of Area A to install a portacabin on this area.
