1. DETAILS

- 1.1 During the period 1 February 2008 to 18 July 2008, 147 interments have been arranged, bringing the total to 21126 since the Cemetery opened on the 1 April 1947. These figures include 740 Muslim burials, which have taken place since space was allocated for this purpose in October 1973. On the 1 April 1995 the cremated remains section was opened and 413 plots have been sold.

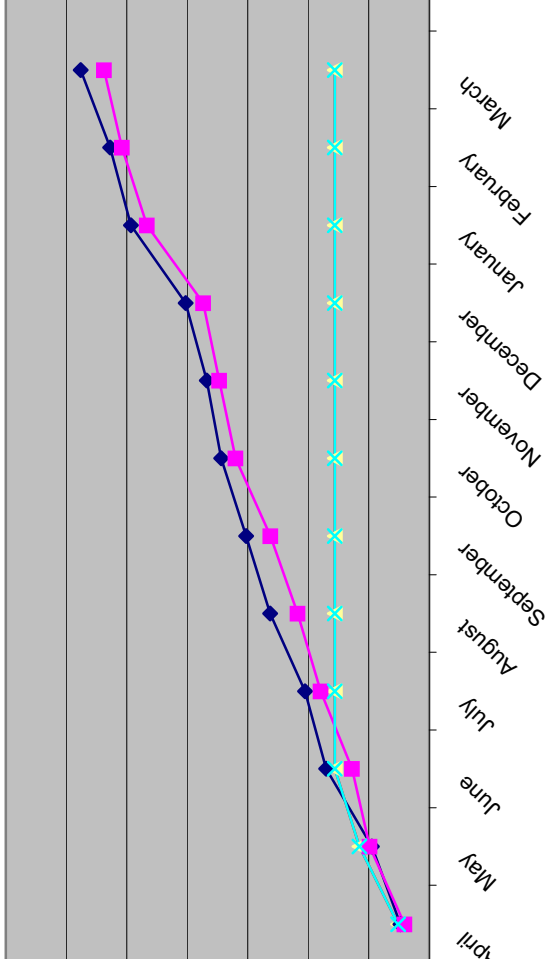
