1.1 The Overview and Scrutiny Commission undertook a review of the night time economy and made recommendations as to how the issues posed by the night time economy can be handled. This report provides an update on progress made on these recommendations.

We recommend that NHS Sutton and Merton and its successors continue with its plans to reconfigure alcohol treatment services so that these will meet the needs of lower level drinkers as well as those who will continue to require in-patient detox services	Drug and Alcohol commissioning (MP)
Action: All Councilors were consulted upon the alcohol Needs Assessment now in final draft form. Safer Merton is currently consulting upon the viability/suitability of re-tendering all local substance misuse services including alcohol	
<b>Date:</b> The Re Tendering is drawing to it's conclusion and all bids have been scored and a winning bidder identified. This is now awaiting Cabinet approval.	
Recommendation 3 (paragraph 34)	
We recommend that Safer Merton works with the Council, Police, NHS and other partner agencies to continue to run the "be social, be sensible, be safe" or a similar campaign.	Cabinet, Safer Merton (MP)
<b>Action:</b> A campaign ran over the Christmas period 2011 utilising existing stocks of campaign material and working with local businesses. There is no funding for future years. Any further campaigns ought to reflect and pay cognizance to the outcomes and findings from the local alcohol needs assessment.	
In conjunction with Public Health and an external marketing agency 2 campaigns are being run that will operate throughout the year (more problematic drinking occurs throughout the Summer Months than over the Xmas Period). These are specifically aimed at Young Women and Young People and those aged 65 and over. They contain a great deal of information including that required below.

Recommendation 4 (paragraph 35)	
We recommend that these campaigns should include information about	Cabinet, Drug

what constitutes a unit of alcohol and the "safe" level of alcohol consumption plus health messages about the impact that alcohol misuse can have.	and Alcohol commissioning (MP)
<b>Action:</b> Unit measuring "wheels" and other items relating to the accurate measurement of units were distributed. However, as pointed out by MP these on their own have little if any real impact upon the drinking attitudes/behaviours of individuals. Much better to coordinate the responses around a full/comprehensive "behaviour change" approach.	
Please see above item, which is specifically aimed more at behavior change.

Recommendation 5 (paragraph 42)	
We recommend that the Council and the Police make greater use of the powers currently available to them in order to deal more stringently with alcohol related antisocial behaviour in local town centres.	Cabinet, Police, ASB team (CC)
<b>Action:</b> Dispersal Zone still in place for Wimbledon town centre & Morden town centre, although not Mitcham town centre. Both Wimbledon & Morden will be looking to renew the dispersal this year. Mitcham now has a Controlled Drinking Zone in and around the town centre.	
Still awaiting change to legislation (that will give police greater powers to deal with asb and drink related asb, and council other ways to apply for public space orders), estimated at end 2014/start 2015. Draft bill produced Dec 2012, but still being tweeked, acting on lots of feedback from community safety teams and others. The Select Committee will make its report to the Home Secretary at the end of February, the actual Bill should be published by Easter and there is an expectation that the Bill will be included in the Queens Speech at the end of May. Assuming a smooth passage Royal Assent should be in March or April 2014 with the new legislation in place by late 2014, which is about one year later than expected.

We recommend that the Council and the Police continue, and increase where appropriate, with mystery shopping and other initiatives to ensure that off-licences do not sell alcohol to under 18s	Cabinet, Police, Trading Standards
Action: The Trading Standards Service continues to operate a regular programme of test purchasing for age-restricted products, including but not limited to alcohol. From 1st April 2012 to the end of January 2013, 179 test purchase exercises have been carried out with 66 of these being alcohol. It is anticipated that 80 alcohol test purchase exercises will be completed by the end of the financial year. Where sales are made to young people under the age of 18 consideration is given to legal proceedings and/or license reviews take place for almost all illegal sales. A similar programme of test purchasing is proposed for 2013/14 however recent guidance from The Better Regulation Delivery Office (part of the Department for Business, Innovation and Skills) is due to come into force	

on 1st June 2013. This will necessitate a comprehensive review of current	
practices and may result in a considerable reduction in the number of test	
purchase exercises carried out.

Action: Proposed changes in the Police Reform and Social Responsibility Act 2011 such as Early Morning Restriction Orders and Late Night Levys may potentially have the effect of reducing trading hours of licensed premises. Other proposed changes will also allow anybody to object to licences and call for premise licence reviews. Conditions are imposed to control noise breakout from premises, which have been recommended by Environmental Health.  Early Morning Restriction Orders and the Late Night Levy are to be considered by the Licensing Committee at the next committee meeting at the end of February.

Recommendation 12 (paragraph 79)	
We further recommend that the Licensing Committee consider how they might use the opportunity of the proposed legislation to further practices that would reduce binge drinking. These may include providing soft drink from vending machines, providing water dispensers, banning selling of shots from trays, stipulate a minimum provision of tables and seating to encourage people to drink more slowly	Licensing Committee, Licensing Team
<b>Action:</b> Mandatory conditions have now been imposed on all 'on licensed' premises to provide free tap water to customers and to ban games or other activities which require or encourage, or are designed to require or encourage, individuals to drink alcohol.
