



Proposed conditions

- 1. There will be no sale or display of beer or cider over 5.5% ABV, except for 6% ABV if sold at £1.49 or more.
- 2. Cans of beer and cider will only be sold in multiples of 4 or more.
- 3. The lowest price at which bottled or canned beer may be sold shall be £1.69
- 4. The lowest price at which canned beer or lager may be sold shall be £1.29
- 5. Unless otherwise required by law there shall be no indication in writing or pictures on any façade facing onto the public highway that the premises sell or are licensed to sell alcohol for consumption off the premises
- 6. Alcohol shall only be displayed or offered for sale within the green line shown on the plan dated 11.04.2017
- 7. Spirits shall be displayed or offered for sale behind the counter shown on the plan dated 11.04.2017 and out of reach of members of the public
- 8. There must be a fully working, good quality digital CCTV system in operation at all times that the premises are open. Recordings must be kept for a minimum of 28 days and be made available to Police with the minimum of delay if requested.
- 9. A Challenge 25 Policy will be strictly operated.
- 10. A refusal and incident log will be strictly maintained and made available immediately to Police on request.
- 11. A minimum of three members of staff to be present at all times that the premises is open.
- 12. A Personal Licence Holder to be present at all times that the premises is open.

The Prevention of Crime and Disorder

1) The sale of all spirits shall be by way of counter service only.

2) A senior member of staff shall be on duty at the premises at all times that alcohol is being sold.3) Alcohol shall only be sold to the public if there are at that time no fewer than two members of staff on the premises.

4) CCTV shall be provided on the premises and shall be kept in good working order at all times.

5) No super strength beers, lagers or ciders of 6% abv or above shall be sold.

## The Protection of Children from Harm

1) The store shall operate a Challenge 25 scheme whereby any person who attempts to buy alcohol who appears to be 21 or under will be asked to provide indentification to prove they are 18 or over. Notices shall be kept on display at the store to inform customers and staff about the scheme. The following forms of identification are acceptable; photo driving licence, passport, proof of age standards scheme (PASS) card and any other locally or nationally approved form of identification.

2) Staff will be trained before they are allowed to sell alcohol on the law and the store's practices and procedures to prevent sales of alcohol to persons under 18.

3) The store shall operate a scanning till with a prompt when age-related products are offered for sale.

4) Staff shall keep a refusals book to record the refusal of sale of any age-related product.
