

What is Overview and Scrutiny?

Overview and Scrutiny describes the way Merton's scrutiny councillors hold the Council's Executive (the Cabinet) to account to make sure that they take the right decisions for the Borough. Scrutiny panels also carry out reviews of Council services or issues to identify ways the Council can improve or develop new policy to meet the needs of local people. From May 2008, the Overview & Scrutiny Commission and Panels have been restructured and the Panels renamed to reflect the Local Area Agreement strategic themes.

Scrutiny's work falls into four broad areas:

- ⇒ Call-in: If three (non-executive) councillors feel that a decision made by the Cabinet is inappropriate they can 'call the decision in' after it has been made to prevent the decision taking immediate effect. They can then interview the Cabinet Member or Council Officers and make recommendations to the decision-maker suggesting improvements.
- ⇒ **Policy Reviews**: The panels carry out detailed, evidence-based assessments of Council services or issues that affect the lives of local people. At the end of the review the panels issue a report setting out their findings and recommendations for improvement and present it to Cabinet and other partner agencies. During the reviews, panels will gather information, evidence and opinions from Council officers, external bodies and organisations and members of the public to help them understand the key issues relating to the review topic.
- ⇒ **One-Off Reviews**: Panels often want to have a quick, one-off review of a topic and will ask Council officers to come and speak to them about a particular service or issue before making recommendations to the Cabinet.
- ⇒ **Scrutiny of Council Documents**: Panels also examine key Council documents, such as the budget, the Business Plan and the Best Value Performance Plan.

Scrutiny panels need the help of local people, partners and community groups to make sure that Merton delivers effective services. If you think there is something that scrutiny should look at, or have views on current reviews being carried out by scrutiny, let us know.

2 DECLARATIONS OF PECUNIARY INTEREST (Agenda Item 2)

There were no declarations of pecuniary interest.

3 MINUTES OF THE PREVIOUS MEETING (Agenda Item 3)

The minutes were agreed as a true and accurate record of the previous meeting.

4 COUNCIL PLAN (Agenda Item 4)

The Leader of the Council, Councillor Ross Garrod, introduced the Council Plan. The plan outlines ambitious plans for the new Administration, focused on the major initiatives and priorities and how we will measure ourselves.

The three key themes are nurturing civic pride, building a sustainable future, and creating a borough of sport.

Delivering the ambition in this plan will require collaborative working not only with our residents and businesses but also with a range of partners at a local and regional level. At the end of the plan, there is a proposed set of key performance indicators by which we can monitor our progress and we can continue to build in targets against those indicators over the course of the next year.

In response to Members of the Commissions questions, the

Several different measurements will be required to monitor progress as some objectives will be milestones while others will remain as ongoing activity.

The document has been designed to be straightforward and easy to read for residents and could become too complex if we were to add all the milestones in under each activity.

The comments around the usefulness of a glossary were also noted.

5 BCU COMMANDER - CRIME AND POLICING IN MERTON (Agenda Item 5)

The Chair welcomed the new Borough Commander, Detective Chief Superintendent, Clair Kelland, to the meeting. The Borough Commander introduced Superintendent Luke Mooney, who will have sole responsibility for Merton Borough, and provided Commission Members with an update on the Commissioner's Turnaround Plan.

Our focus will be on strengthening our neighbourhood policing. In terms of local issues that impact our communities, there will be a renewed focus on precision policing. We now have new data and technology that will allow us to take an intelligence led approach and on a day-to-day basis identify both those high harm prolific offenders but also those offenders that commit community crimes.

Externally we will focus on how we can better listen to our communities, public protection, safeguarding and how we respond to violence against women and girls.

The Borough Commander will be setting up an Ethics board internally to look at misconduct data, including both internal and external complaints from the public, and see whether we can identify any thematic issues so that we can be proactive in responding to that behaviour of officers.

In response to supplementary questions from Commission Members, the Borough Commander expanded as below:

Merton is the fourth safest Borough in the MPS. The last three months have seen a reduction again in knife crime and this is likely due to additional resources being put in place, following robbery issues in the area, and that visible police presence has driven down crime.

There is a strengthening public protection program within the MPS and one of the Commissioner's priorities is reducing violence against women and girls.

Operation Vigilant is now going to be deployed in the southwest – this is a proactive policing operation where plain clothes officers observe perpetrators behaviour in hotspots to develop an intelligence base. The basis of it is that officers intervene before an offense takes place and that led to a 24% reduction of all offenses within those hot spot areas.

Crime figures - there has been a 5% increase in total notifiable offenses emerging in the last 12 months, although we've seen a slight dip again in the last three months, so things are very much moving in the right direction.

The Borough Commander is keen to continue attending the Independent Advisory Group meetings.

Burglary figures have gone down with a reduction of 1.4%. There were 783 burglaries in Merton in the last year which is 1.4% less than the previous year. SD rates for the Southwest are at about 4% so definitely a lot of work to do in that area. A bespoke burglary team has been created, with its own Inspector and Sergeant, so that we can focus on burglaries in the borough and reduce that number as well as increase our detection rate.

As part of the ethics board work, we will be developing a process to review the footage from body worn videos looking at the grounds for the search and also the quality of that interaction.

Crime Stoppers launched a campaign last autumn called Fearless which is a good method for encouraging young people to report crimes anonymously. Safer Merton have made an application for funding to continue this campaign.

We have a dedicated gang's team within our local investigation strand and following an eight-month covert proactive operation, that team ensured some very senior gang members received custodial sentences.

The Chair thanked the Borough Commander for her attendance.

6 PUBLIC SPACES PROTECTION ORDER (PSPO) (Agenda Item 6)

The Interim Assistant Director of Public Protection introduced the item.

A Public Space Protection Order allows a local authority to make an order to prohibit certain behaviours.

Consultation showed that 79% of residents are in support of a borough wide PSPO to deal with alcohol-related antisocial behaviour

The original five ward PSPO approved by Cabinet back in September led to roughly 244 interventions but very little enforcement, which demonstrates the approach that

we've taken. The reason for going borough wide is so that we can have a consistent approach across the borough and deal appropriately with any displacement issues.

In response to questions, the Interim Assistant Director of Public Protection added further clarifications.

It's a priority for us as an administration to take this type of antisocial behaviour seriously.

Recognising that some of our most prolific street drinkers are vulnerable/have complex psychological/addiction issues, we have started working with Public Health and other departments looking at assertive outreach and support. There is a post that's being recruited to currently which will be funded between the drug and alcohol misuse service, public health, and the homelessness team who will have responsibility for this large piece of work.

The signs are intended to clearly signal that we want we this to be a responsible drinking borough. Comments from a Commission Member on the need to redesign the sign were noted by officers.

7 WORK PROGRAMME / TOPIC SUGGESTIONS (Agenda Item 7)

1 PURPOSE OF REPORT AND EXECUTIVE SUMMARY

Dear OSC Members,

Safer Merton attended OSC in March 2023 with regards to making a borough wide alcohol related PSPO, which was approved by Cabinet. The legal Order is currently being made and will commence on 25th July 2023. It should be noted there will be a 6-week appeal period following commencement. A communications plan for residents, partners and Members is being developed.

Thank you for your feedback at OSC with regards to redesigning the PSPO signage. Attached are the final versions of the signs as approved by Cllr Stringer. We worked with Comms and Legal to produce the signs, which make clear the Order is not a ban on drinking alcohol, but an encouragement of responsible drinking, whilst ensuring the Council covers the legal requirements of the Order. There are two versions of the sign, one for wards covered by the existing PSPO which discharge the old Order, and one for wards where the PSPO is new.

The signs will be erected on lampposts in A4 correx across the borough by 25th July 2023. Once the appeal period is over and the Council's corporate rebrand has been completed, we will work to produce larger metal signage where appropriate.

We will be providing an update on the PSPO as part of our next report to OSC in September.


Over the summer we will also be holding briefings for Members and partners to assist in understanding the PSPO and its remits.





Foreword

Scrutiny is at the heart of the decision-making process in Merton and is a forum for councillors to discuss complex local issues. This past year, the **Sustainable Communities**Overview and Scrutiny Panel has helped shape the future of the borough's waste collection services. The Overview and Scrutiny Commission assembled a working group to review options for the future of CHAS 2013 Ltd. The Healthier Communities Overview and Scrutiny Panel has overseen a review of day care opportunities, to ensure a variety of activities are available for vulnerable residents. The Children and Young People Overview and Scrutiny Panel held a special session to understand their role as corporate parents and to review current service provision for looked after children.



Councillor Edward Foley, Chair of the Overview and Scrutiny Commission, said: "It has been a busy year for scrutiny. New councillors have become acquainted with their role in holding decision makers to account. We have welcomed residents to scrutiny meetings, visited services and held budget scrutiny training sessions. Thanks to commitment from

councillors, we have run more task groups this year than ever before. I have met with Chairs and Vice Chairs to map out continuous improvement for the function."

Scrutiny in action

Merton's Violence
Against Women and
Girls strategy (VAWG)
was presented to
the Overview and
Scrutiny Commission,
along with plans to
obtain white ribbon
accreditation, in order
to demonstrate the
Council's commitment
to engaging with



men and boys to end violence against women and girls. Commission members supported this work by placing a strong focus on the safety of women and girls in their agendas this municipal year. The Borough Commander and Safer Merton officers were in regular attendance at meetings. Merton Council has since achieved White Ribbon accredited status, and will make changes to communications, HR policies, employee development, training, and overall organisational culture.


The Chair of the Children and Young People Overview and Scrutiny Panel led on a plan to enhance the participation of young people within scrutiny. As a result, a young inspector has been appointed to the Commission and each of the Panels for a one-year pilot scheme. The Young Inspectors will draw on the experiences of young people across the borough and enable their voices to be heard. Xxxxxxx Xxxxxx LM Young Inspector •

said: "Being a Young Inspector on the scrutiny panel has been an innovative experience as this has allowed me to ensure young people's views are heard within these settings and by decision-makers. As a Young Inspector sitting on the Healthier Communities and Older People Panel, I have been able to hear about the initiatives being delivered for our older residents and challenge our decision-makers to ensure these services are also reaching younger residents"

Following a presentation on the fly-tipping strategy, members of the **Sustainable Communities Overview and Scrutiny Panel** made a cross party recommendation that Cabinet look at ways to involve the community to develop plans on the collection of waste. May 2023 saw the first two pilots of 'Garth Road on the Road', a pop-up tip for residents who live in Pollards Hill, and another in the St Helier and Ravensbury area, to dispose of their excess household rubbish, recycling, green waste, and bulky items.

Improving the uptake of breast screening is a major concern for the **Healthier Communities and Older People Overview**

and Scrutiny Panel. NHS colleagues were asked to provide simple messages on the importance of screening which councillors can then share with the community. Panel members



continue to advocate for an accessible breast screening clinic within the borough. This will support vulnerable people and make it easier for residents to get to.

In September 2022 the Sustainable Communities Overview and Scrutiny Panel agreed to undertake a scrutiny review of **Electric Vehicle (EV) Charging in Merton**. The EV Task Group considered the current progress of the EV charger rollout and the anticipated future demands and helped to shape the Council's upcoming Electric Vehicle Strategy. The strategy will set out Merton's vision and policy, and estimate the infrastructure needed in the coming years and consider how this work could be implemented. Delivery will include spreading a range of charging types

and speeds as
evenly as possible
throughout the
borough, how
to manage street
decluttering and possible
solutions to cable
channels on pavements.
At the time of publishing



this annual report, the group's recommendations were scheduled for Cabinet but not yet approved.

A review on **Youth Funding** is looking at the role of Young People's Foundations as a vehicle to attract funding sources. Task Group members have met with council officers, the voluntary sector, and examined work taking place in other local authorities. They are due to report their findings later this year.

A review on **Employment Opportunities for People with Autism** is looking at the role of the council as a community leader in providing employment for neuro diverse people.

The review will report later this year.

This year, two additional councillor-led task groups were conducted with reduced officer support. This has increased activity within the function and provided more opportunities to put forward recommendations on issues of public concern.

A review looking at **community toilets** has received over 900 responses to a public survey. Recommendations are currently being drawn up. The review on **Reducing Eating Disorders and Self Harm amongst Young People** has completed. Recommendations focussed on training for professionals and promoting support services. Councillors have been pleased outcomes from previous reviews.

The majority of the recommendations from a Children's Mental Health Task Group have been implemented including specialised training for school governors, expansion of mental health first aid training to schools, collaborative work between youth parliament and young inspectors to improve communication



material. A pilot social prescribing scheme for children and young people is in place.

The recommendations from a **High Street Task Group** led to a council funding pot of £50,000 to procure culture led projects across the borough.
