- 1.1. This report provides the panel with the report to Cabinet on Merton Priory Homes Governance dated 16 January 2017.
- 1.2. The Cabinet report is provided in order to brief the panel on Circle's plans to simplify the group structure and consolidate the nine housing associations in the group, including Merton Priory Homes (MPH), into one association.
- 1.3. The Cabinet report seeks members agreement on the Council's position on these plans.
- 1.4. Circle Housing are implementing a programme known to Circle as "Resurgence". Circle are not currently in a position to implement this in Merton without the council's approval, which they have requested with regards to variations to the Stock Transfer Agreement.

It is necessary, in its role as shareholder, for the council to also agree a position on how to exercise its vote in forthcoming shareholder meetings on the proposals and whether they are in the best interests of tenants and leaseholders in providing accountability for their performance and services within Merton.
- 1.6. The report to Cabinet seeks to set out Circle's plans, the powers of the council and the impact on the MPH residents.
