To sell general public alcohol according to their needs.
There used to be cost cutter 58 Wimbledon hill Road that held off license for selling alcohol, which is closed for Refurbishment for whole building.

b) The prevention of crime and disorder

Making sure that council rules are applied, such as “code of good conduct” in order to prevent selling alcohol products to under age individuals.

c) Public safety

Making sure that health and safety is the first priority during opening hours for staff and general public. We are working closely with the local police to prevent crime and frauds, we will refuse to sell alcohol to drunken customers and making sure annoyance is avoided in the premises that would affect public and employees.

d) The prevention of public nuisance

We will implement health and safety and crimes disorder prevention strategies under council guidelines to reduce nuisance

e) The protection of children from harm

Making sure that alcohol is not sold to under age children. Where necessary will be checking their ID.
