1. Special Policy Area (premises licences and club certificates)

The premises are not in the special policy area.

2. Type of hearing and powers of the sub-committee

- 2.1 The sub-committee is required to determine the application by taking such of the steps set out below as it considers appropriate for the promotion of the licensing objectives.
- 2.2 In making their determination the sub-committee must have regard to the Licensing Act 2003, the licensing objectives, guidance issued by the Secretary of State and Merton's Licensing Policy.
- 2.3 Variation of premises licence: s34
 - (i) To modify the conditions of the licence
 - (ii) To reject the whole or part of the application

3. Hearing papers

The applications, notices and representations for determination by the subcommittee are contained in the hearing bundles together with any relevant existing licence. This includes any documents which must be sent to any of the parties to the hearing under Regulation 7(2) and Schedule 3 of The Licensing Act 2003 (Hearings) Regulations 2005. This bundle has been issued to all parties to the hearing.

4. Legal advice to the sub-committee

4.1 A legal officer appointed by the Assistant Director of Corporate Governance and Head of Legal Services will attend the hearing to advise the subcommittee on statutory provision and legal matters.

5. Licensing Officer comments

- 5.1 This application is to vary existing premises licence number LN/000005644 for Plough Lane Stadium, Plough Lane, London.
- The brief nature of the proposed variation is described as: Alteration to the hours which the licence holder can serve alcohol to patrons within the stadium, corporate suites and directors' boxes. Also, alteration to the conditions in relation to the supply of alcohol to, inter alia, coincide with and support the change in hours which the licence holder can serve alcohol to patrons within the premises licence area.

- The conditions that the applicant wishes to amend in the attached variation application form shows the conditions as listed on the original new premises licence application form. The applicant was asked to clarify which conditions as attached to the current premises licence they wished to amend. This clarification was received and is attached after the variation application form in the report.
- The application would also seek to amend the times for the supply of alcohol in the different areas of the stadium covered by the premises licence, also standardising the times for the three corporate suites. Corporate Suite 1 has different timings to Corporate Suites 2 and 3.
- 5.5 The Corporate Suites The variation would standardise the supply of alcohol timings as follows: Monday to Thursday 9am to 00:30 the following day, Friday and Saturday 9am to 1am the following day and Sunday 9am to 11:30pm.
- 5.6 The opening hours for the corporate suites are currently Monday to Thursday 9am to 00:30 the following day, Friday and Saturday from 9am to 1:30am the following day and Sunday 9am to midnight.
 - The variation changes Friday and Saturday from 9am to 1am the following day.
- 5.7 <u>The Directors Boxes</u> The variation seeks to increase the times for the supply of alcohol from Sunday to Thursday 11am to 11pm and on Friday from 10am to 11pm. There is currently no authorisation for the sale of alcohol on a Saturday.
 - Increasing to Monday to Thursday 9am to 00:30am the following day, Friday and Saturday from 9am to 1am the following day and Sunday 9am to 11:30pm.
- 5.8 The opening times for the Directors boxes would also increase. They are currently Monday to Friday 11am to 11:30pm, Saturday 10am to 11:30pm and Sunday 11am to 11pm.
 - The variation application would seek to increase the opening times to Monday to Thursday 9am to 00:30am the following day, Friday and Saturday 9am to 1am the following day and Sunday 9am to midnight.
- 5.9 <u>The Main stadium</u> The times for the sale of alcohol are currently Monday to Thursday 11am to 11pm, Friday 10am to 11pm and Sunday 11am to 9pm. There is currently no authorisation for the sale of alcohol on Saturday.
 - The variation application seeks to increase these to Monday to Sunday 9am to 11pm.
- 5.10 The opening hours for the main stadium are currently Monday to Friday 11am to 11pm, Saturday 10am to 11pm and Sunday 11am to 9pm.
 - The variation seeks to increase these to Monday to Sunday 9am to 11pm
- 5.11 The applicant has not put any further steps in their operating schedule that they will take to promote the four licensing objectives.
- We received 11 representations regarding this application from persons who live in the locality.

 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.





ANNEX 1 TABLE OF MANDATORY CONDITIONS UNDER THE LICENSING ACT 2003

- 1. That no supply of alcohol may be made under the premises licence
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- **2**. That every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- **3**. Where one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority by a licence granted under the Private Security Industry Act 2001 or entitled to carry out that activity by virtue of section 4 of the Private Security Industry Act 2001.
- **4.** (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

- **5.** The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- **6.** (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 7. The responsible person must ensure that -
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- **8.** A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

For the purposes of the condition set out in paragraph 1—

- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula—

 $P = D + (D \times V)$

where -

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or

- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

9. The admission of children to the exhibition of any film is to be restricted in accordance with any recommendation made by the relevant film classification body or relevant licensing authority.

Licensing Act 2003 - Section 177a

The provision of entertainment consisting of the performance of live music and recorded music is not to be regarded as the provision of regulated entertainment provided:

- Music takes place on premises which are authorised by a premises licence or club premises certificate to be used for the supply of alcohol for consumption on the premises,
- At the time of the music, the premises are open for the purposes of being used for the supply of alcohol for consumption on the premises,
- If the music is amplified, it takes place in the presence of an audience of no more than 500 patrons, and
- The music takes place between 8am and 11pm on the same day.

- 46. Clearly legible notices shall be prominently displayed at any area used for smoking outside the premises requesting patrons to respect the needs of local residents and to use the area quietly.
- 47. A record of complaints shall be maintained on the premises to record details of any complaints received. The information to be recorded shall include the date and time of complaint and subsequent remedial action undertaken and (where disclosed) the complainant's name and location.
- 48. The record of complaints shall be kept for 12 months from the date of the last record made and shall be available for inspection on demand by the police or an authorised officer of the Licensing Authority at all times the premises are open.
- 49. On days where there is a sports event, customers shall not be permitted to remove from the premises any drinks supplied by the premises (alcoholic or otherwise) save for sealed items purchased at the club shop.

All staff members engaged, or to be engaged, in selling alcohol at the stadium shall receive the following training in age-restricted sales: Induction training as to the lawful selling of age restricted products prior to the selling of such products, and verbal reinforcement/refresher training thereafter at regular intervals of not less than 6 months with the date and time of the training recorded.
- 54. At each point of sale within the premises there shall be a visual prompt to staff members reminding them to undertake appropriate age checks on potential sales of alcohol
- 55. On days when there are matches or events taking place at the stadium an operational plan shall be in place to ensure should staff encounter a child who appears distressed, the matter will be dealt with by identified and trained staff aware of the issues relating to child protection and suitably CRB checked to deal with issues such as lost and found children.
- 56. All coloured areas stated in these conditions shall relate to the areas so coloured in the plan attached to the licence.



I hope that you are well.

I am emailing as a resident of with regards to the amended licensing application made in relation to AFC Wimbledon Stadium to extend the hours of opening and alcohol sales.

I note that the application mainly proposes earlier opening times and alcohol sale times. I am concerned that the additional 2 hours of alcohol sales in the morning could lead to more noise and disruption when attendees leave the stadium. At present there is often loud singing and cheering when attendees leave. Additionally, there are many incidents of littering and public urination around the building where I live. My objection to the extended hours of sale in the morning is that incidents of disruptive and anti-social behaviour would very likely increase due to the opportunity this provides for increased alcohol consumption on site.

I also object to the extended opening times and alcohol sale hours in the evenings for all corporate suites and the director boxes. I note that at the moment only one corporate suite (out of three) has the proposed opening hours, and that the other two suites have slightly shorter licensing hours. Additionally the directors box currently has a licence for alcohol sales until 11pm.

Under the current licensing hours individuals visiting the directors box and corporate suites have staggered closing times which means that any noise and disruption from those individuals leaving is spread across the evening and there is not a single large exodus in the early hours. If all three corporate suites and the directors boxes have the same extended closing time as Corporate suite 1 then the number of individuals exiting the stadium late at night/in the early hours of the next morning will increase. As noted above, this would result in an increase in noise at unsociable hours, and likely an increase in anti-social behaviours in the development surrounding the stadium.

Additionally, there have been many incidents of theft of parcels and bicycles from the development. I am concerned that the increased volume of individuals leaving the property at any one time could provide additional opportunity for thefts due to the cover of a busy crowd.

Please therefore accept my objection to this licensing application in light of the above concerns in relation to an increase in noise levels late at night and anti-social behaviours. In addition, the larger volumes of individuals leaving could provide more opportunity for crime and disorder.

Based on my above representations I therefore believe that the licence extention is contrary to the objectives of the prevention of crime and disorder (anti-social behaviour and theft of parcels and bikes as noted above), and the prevention of public nuisance (public urination and singing/cheering as exiting the venue as noted above).
