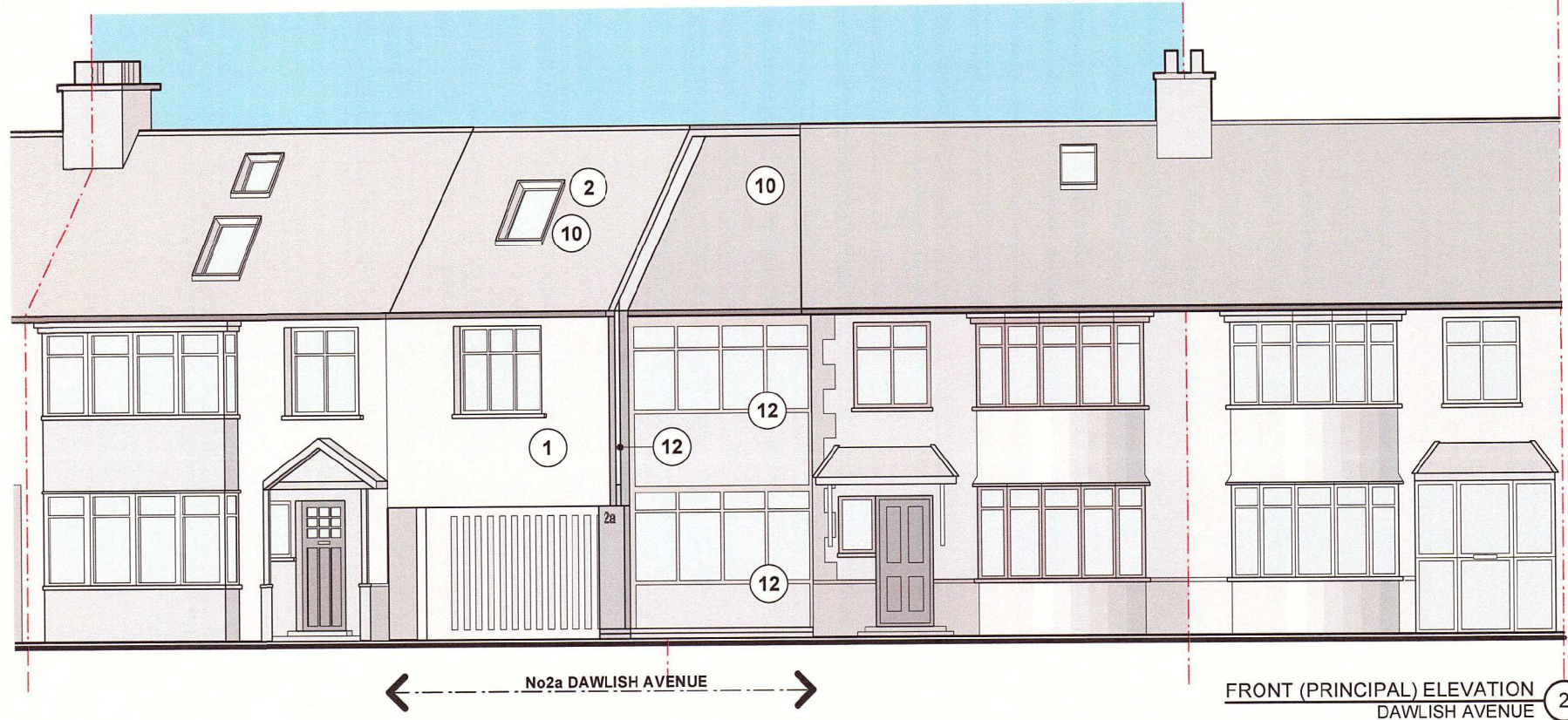

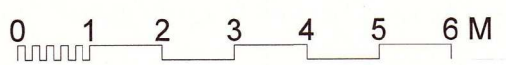

12	Framed operable and fixed double glazed windows / doors



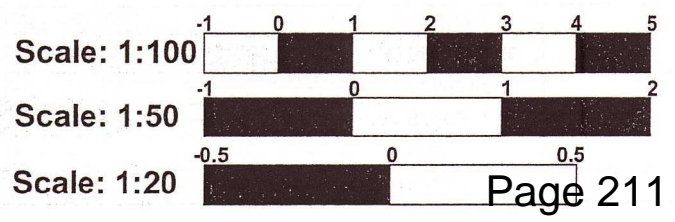
